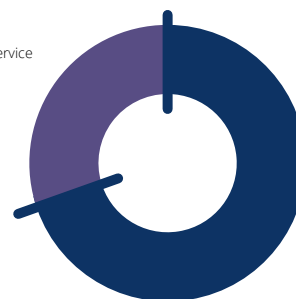

#### WEEK IN REVIEW

- NPD COORDINATED WITH CLEVELAND CO. FIRST RESPONDERS TO HOST CLASH FOR CAUSE RAISING MORE THAN \$30,000 FOR THE ABBOTT HOUSE CHILD ADVOCACY CENTER. OUR VERY OWN MPO HARLEY RHYNES THREW OUT THE FIRST PITCH TO KICK OFF THE GAME. CONGRATULATIONS TO THE 2023 CHAMPIONS, THE MOORE FIRE DEPARTMENT.
- OFFICERS RESPONDED TO A REPORT OF A SHOOTING AT 103 W. ACRES ON 9/13. ONCE ON SCENE, OFFICERS LOCATED ONE SUBJECT SUFFERING FROM A GUNSHOT WOUND TO THE LEG. THE SUBJECT WAS TRANSPORTED TO AN AREA HOSPITAL FOR A NON-LIFE-THREATENING INJURY. THE PRELIMINARY INVESTIGATION INDICATES THAT THE GUNSHOT WOUND WAS SELF-INFLICTED.
- PATROL AND P.A.C.E. RESPONDED TO A BUSINESS IN THE 400 BLK OF W. MAIN FOR A WELFARE CHECK ON 9/14. A CUSTOMER REPORTED THEY HAD BEEN KIDNAPPED AND KEPT IN THE TRUNK OF THEIR OWN VEHICLE. THE TWO SUSPECTS WERE WAITING IN THE VICTIM'S CAR IN THE PARKING LOT. THE SUSPECTS ATTEMPTED TO FLEE WHEN OFFICERS ARRIVED. OFFICERS ENGAGED IN A BRIEF VEHICLE PURSUIT THAT ENDED NEAR ACRES ST. AND BERRY RD. BOTH SUSPECTS WERE ARRESTED AND BOOKED INTO CCDC ON NUMEROUS CHARGES.
- OFFICERS RESPONDED TO A DISTURBANCE INVOLVING WEAPONS IN THE 1200 BLK OF E. LINDSEY ON 9/16. WITNESSES REPORTED THAT TWO INDIVIDUALS WERE ACTIVELY ENGAGED IN A VERBAL ALTERCATION WHEN ONE PRESENTED A FIREARM. THE UNARMED INDIVIDUAL ATTEMPTED TO LEAVE THE AREA. THE ARMED INDIVIDUAL ENTERED HIS VEHICLE AND FOLLOWED THE OTHER MALE TO A NEARBY ALLEYWAY FIRING MULTIPLE SHOTS AT HIM. THE ARMED INDIVIDUAL WAS DRIVING AWAY FROM THE SCENE AS OFFICERS WERE ARRIVING. OFFICERS STOPPED THE VEHICLE IN THE AREA OF BRANDYWINE AND LINDSEY FOLLOWING A SHORT PURSUIT. THE SUSPECT WAS TAKEN INTO CUSTODY WITHOUT INCIDENT AND BOOKED INTO CCDC ON CHARGES OF DISCHARGING A FIREARM FROM A MOVING VEHICLE, FELONY ELUDING, DUI, POSSESSION OF FIREARM WHILE INTOXICATED, POSSESSION OF MARIJUANA, AND DRIVING WITHOUT A LICENSE.
- ANIMAL WELFARE HAD 33 ANIMALS ADOPTED AND 11 ANIMALS RECLAIMED BY THEIR OWNER. ADDITIONALLY, THEY TOOK IN A TOTAL OF 60 ANIMALS INTO THE ANIMAL WELFARE CENTER THIS WEEK. ANIMAL WELFARE CURRENTLY HAS 224 ANIMALS IN THEIR CARE WITH 80 OF THOSE ANIMALS CURRENTLY IN PLACEMENT WITH FOSTERS.
