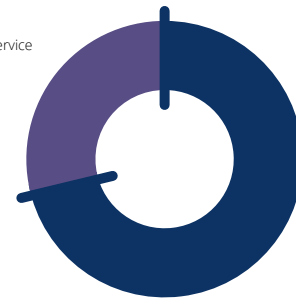

WEEK IN REVIEW

- WITH THE ASSISTANCE OF MORE THAN A DOZEN LAW ENFORCEMENT PARTNERS, NPd CRIMINAL INVESTIGATIONS DIVISION WAS ABLE TO SAFELY LOCATE A MISSING 23YO MOM AND HER 10-MONTH-OLD SON FOLLOWING ISSUANCE OF AN AMBER ALERT. ON THE MORNING OF JULY 26, NORMAN INVESTIGATORS RECEIVED INFORMATION THAT INDICATED BOTH THE WOMAN AND CHILD COULD BE IN IMMINENT DANGER DUE TO EVIDENCE OF A POSSIBLE NEXUS TO INTERSTATE SEX TRAFFICKING. THE TWO WERE LOCATED SAFE IN HOUSTON, TEXAS ON JULY 27. NPd GREATLY APPRECIATES THE ASSISTANCE PROVIDED BY MULTIPLE LOCAL, STATE, AND FEDERAL LAW ENFORCEMENT AGENCIES SINCE RECEIPT OF THE INITIAL REPORT. THE COORDINATED INVESTIGATIVE EFFORTS AND LAW ENFORCEMENT PARTNERSHIP WERE KEY TO LOCATING BOTH THE WOMAN AND HER CHILD SAFE.
- ANIMAL WELFARE HAD 32 ANIMALS ADOPTED, 9 ANIMALS RECLAIMED BY THEIR OWNERS AND 1 ANIMAL TRANSFERRED OUT TO RESCUES THIS WEEK. ADDITIONALLY, THEY TOOK A TOTAL OF 62 ANIMALS INTO THE ANIMAL WELFARE CENTER. ANIMAL WELFARE CURRENTLY HAS 205 ANIMALS IN THEIR CARE WITH 62 OF THOSE ANIMALS CURRENTLY IN PLACEMENT WITH FOSTERS.
- OFFICERS RESPONDED TO A REPORT OF A DOMESTIC DISTURBANCE IN THE 300 BLK. OF 48TH NW ON JULY 24. AN INDIVIDUAL KNOWN TO THE RESIDENT RETURNED AFTER AN EARLIER ARGUMENT, BROKE A WINDOW, AND TRIED TO UNLOCK THE DOOR. ONE OF THE RESIDENT'S FAMILY MEMBERS ARRIVED (WITH A GUN) AND CONFRONTED THE INDIVIDUAL RESULTING IN A PHYSICAL ALTERCATION BETWEEN THE TWO. DURING THE FIGHT, THE SUSPECT WAS HIT WITH THE FIREARM CAUSING IT TO DISCHARGE. NO ONE WAS HIT. THE SUSPECT WAS TRANSPORTED TO A LOCAL HOSPITAL FOR INJURIES SUSTAINED DURING THE FIGHT. AN ARREST WARRANT WAS ISSUED IN CONNECTION TO THE INCIDENT.
- OFFICERS RESPONDED TO A FIGHT IN THE 200 BLK. REED AVE. AT NOON ON JULY 25. UPON ARRIVAL, OFFICERS LOCATED ONE OF THE SUSPECTS ARMED WITH A PIPE. DUE TO QUICK INTERVENTION AND UTILIZATION OF DE-ESCALATION TECHNIQUES, THE OFFICERS WERE ABLE TO PREVENT HIM FROM SWINGING IT OR HITTING ANYONE. THE TWO SUSPECTS INVOLVED IN THE INCIDENT WERE QUICKLY IDENTIFIED AND ARRESTED FOR A COMBINATION OF ACTIVE WARRANTS, TRESPASSING, AND/OR PUBLIC INTOXICATION.
- OFFICERS RESPONDED TO A REPORT OF A SINGLE VEHICLE COLLISION AT THE RAILROAD CROSSING ON TECUMSEH RD. ON JULY 28. THE INITIAL INVESTIGATION INDICATES A MOTORCYCLIST WAS DRIVING WEST ON TECUMSEH RD. WHEN THEY STRUCK THE CENTER DIVIDER AND LOST CONTROL OF THE MOTORCYCLE RESULTING IN A CRASH. THE MOTORCYCLIST SUSTAINED A HEAD INJURY DURING THE COLLISION AND WAS TRANSPORTED TO A LOCAL HOSPITAL FOR FURTHER EVALUATION AND MEDICAL CARE.
