#### **WEEK IN REVIEW**

- · OFFICERS OBSERVED A VEHICLE LEAVING A BUSINESS AT FLOOD AVE AND ROBINSON ST ON 10/24. THE VEHICLE FAILED TO YIELD PRIOR TO TURNING ONTO NB FLOOD. OFFICERS ALSO OBSERVED A PERSON RUNNING AFTER THE VEHICLE YELLING ABOUT A CHILD. OFFICERS ATTEMPTED TO CONTACT THE VEHICLE, BUT IT REFUSED TO STOP. THE VEHICLE SUBSEQUENTLY CRASHED INTO A FENCE. AND THE DRIVER FLED ON FOOT. THE INITIAL INVESTIGATION DETERMINED THAT THERE WERE NO CHILDREN IN THE VEHICLE, BUT THE DRIVER HAD TAKEN THE VEHICLE WITHOUT THE OWNER'S CONSENT. A WARRANT WAS REQUESTED FOR THE DRIVER.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION INVOLVING A MOTORCYCLE AND VEHICLE IN THE 500 BLOCK OF EMERALD WAY AT APPROXIMATELY 8:58PM ON 10/26. THE MOTORCYCLIST WAS TRANSPORTED TO AN AREA HOSPITAL WHERE HE WAS LATER PRONOUNCED DECEASED DUE TO INJURIES SUSTAINED DURING THE COLLISION. THE DRIVER OF THE VEHICLE DID NOT SUSTAIN ANY INJURIES DURING THE COLLISION. THE CAUSE OF THE COLLISION REMAINS UNDER INVESTIGATION BY THE NPD COLLISION INVESTIGATION AND RECONSTRUCTION TEAM (CIRT).
- OFFICERS RESPONDED TO A REPORT OF GUNSHOTS IN THE AREA 12TH AVE SE AND COMMERCE DR ON 10/26. CALL NOTES DESCRIBED A POSSIBLE SUSPECT AND AN OFFICER FOUND A PERSON MATCHING THE GENERAL DESCRIPTION WALKING IN THE AREA. THE INITIAL INVESTIGATION INDICATED THAT THE SUSPECT STOOD IN ROADWAY, STOPPED A VEHICLE, POINTED A GUN AT THE DRIVER, AND ATTEMPTED TO OPEN A CAR DOOR NEAR WHERE THE DRIVER'S 3YO CHILD WAS SITTING. THE DRIVER FLED THE AREA AND CALLED POLICE. A TOY GUN, MATCHING THE DESCRIPTION GIVEN BY THE DRIVER, WAS FOUND BY OFFICERS NEAR WHERE THE SUSPECT WAS STOPPED. THE SUSPECT WAS ARRESTED AND BOOKED INTO THE CLEVELAND COUNTY DETENTION CENTER.
