## WEEK IN REVIEW

THE TWO RAN OUT OF THE RESIDENCE BUT WERE LOCATED SHORTLY AFTER BY PATROL OFFICERS WITH THE VICTIM'S PROPERTY. BOTH WERE TRANSPORTED TO A JUVENILE DETENTION CENTER.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION IN THE AREA OF 24TH AVE SE AND WHEATLAND DR ON APRIL 19 AT 6:14PM. UPON ARRIVAL, OFFICERS DETERMINED A DRIVER WITH SUSPECTED IMPAIRMENT STRUCK ANOTHER VEHICLE AND THEN A UTILITY POLE. THE DRIVER WAS TRANPORTED TO OU MEDICAL WHERE HE DIED FROM INJURIES SUSTAINED DURING THE COLLISION. THE COLLISION REMAINS UNDER INVESTIGATION.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION IN THE AREA OF W. TECUMSEH ROAD AND HEALTHPLEX PARKWAY ON APRIL 21 AT 10:24AM. THE INITIAL INVESTIGATION REVEALED THAT A VEHICLE VEERED LEFT OF CENTER COLLIDING WITH ONCOMING TRAFFIC CAUSING A CHAIN REACTION OF COLLISIONS AND THE INITIAL VEHICLE TO ROLLOVER.
