## WEEK IN REVIEW

- COMMUNICATIONS RECEIVED A CALL OF A STABBING AT CAMPUS CORNER. THE VICTIM WAS STABBED 3 TIMES IN THE BACK BY AN UNKNOWN ASSAILANT WHILE STANDING IN A PARKING LOT. OFFICERS CONDUCTING FOOT PATROL IN THE AREA, AND RENDERED IMMEDIATE AID. THE INVESTIGATION REMAINS UNDER INVESTIGATION.
- OFFICERS WERE DISPATCHED TO A SUBJECT RUNNING IN TRAFFIC, HALLUCINATING, AND ATTACKING VEHICLES NEAR THE 2100 BLK OF W. LINDSEY ST. UPON ARRIVAL, OFFICERS FOUND FIRE AND EMSTAT TRYING TO CONTROL THE HIGHLY INTOXICATED SUBJECT. OFFICERS ASSISTED WITH DETAINING THE SUBJECT AS HE WAS EVALUATED BY PARAMEDICS. DURING TRANSPORT TO A LOCAL HOSPITAL, THE SUBJECT EXPERIENCED A SERIOUS MEDICAL EPISODE, BUT WAS STABILIZED AND THEIR PROGNOSIS CONTINUES TO BE POSITIVE.
OFFICERS RESPONDED TO A DOMESTIC VIOLENCE INCIDENT IN THE 600 BLK OF E. APACHE ST. THE SUSPECT HAD ASSAULTED THE VICTIM OVER SEVERAL DAYS AND THREATENED TO KILL POLICE. THE SUSPECT WAS ARMED WITH KNIVES AND A RIFLE. SWAT WAS NOTIFIED. OFFICERS ON PERIMETER ENGAGED THE SUSPECT TRYING TO LEAVE THE AREA AND PLACED HIM UNDER ARREST WITHOUT INCIDENT. OFFICERS WERE CALLED TO A HIT-AND-RUN COLLISION NEAR WOOD VALLEY RD AND WHEATLAND DR. THE VECHICLE WAS FOUND NEARBY AND CHECKED AS STOLEN. LATER, OFFICERS RESPONDED TO THE 600 BLK OF SUNRISE FOR ROBBERY WHERE TWO SUBJECTS, MATCHING THE DESCRIPTION FROM THE STOLEN VEHICLE, TRIED TO STEAL THE VICTIM'S SKATEBOARD AT GUNPOINT OFFICERS LOCATED THE SUSPECT IN A NEARBY APARTMENT COMPLEX. AFTER A BRIEF STANDOFF, ALL SUBJECTS EVENTUALLY SURRENDERED WITHOUT FURTHER INCIDENT
