## WEEK IN REVIEW

- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION AT ROBINSON ST AND FLOOD AVE ON 10/17. THE INITIAL INVESTIGATION INDICATES THAT A VEHICLE WAS STOPPED EASTBOUND FOR A RED LIGHT WHEN ANOTHER VEHICLE HIT IT FROM BEHIND at a high rate of speed. ONE VEHICLE THEN Struck a pole, and the other VEHICLE ROLLED AND CAUGHT FIRE. THE DRIVERS OF BOTH VEHICLES WERE PRONOUNCED DECEASED AT THE SCENE. THE COLLISION REMAINS UNDER INVESTIGATION BY THE NPD/OUPD CIRT TEAM.
AN OFFICER ATTEMPTED A TRAFFIC STOP ON A RECKLESS DRIVER IN THE AREA OF MCGEE AND HWY 9 ON 10/21. THE SUSPECT VEHICLE DID NOT STOP AND CONTINUED TO DRIVE ERRATICALLY. OFFICERS EVENTUALLY DISABLED THE VEHICLE AFTER SEVERAL ATTEMPTED TVIS. TWO OF THE FOUR OCCUPANTS WERE ARRESTED ON CHARGES OF FELONG ELUDING, DUI UNDER 21, UNLAWFUL POSSESSION OF A FIREARM WHILE INTOXICATED, AND VARIOUS DRUG-RELATED CHARGES.
PATROL AND CIRT OFFICERS RESPONDED TO AN INJURY ACCIDENT INVOLVING A MOTORCYCLE NEAR BART CONNER DR AND 36TH AVE NW ON 10/21. THE MOTORCYCLIST WAS NOT WEARING A HELMET AND SUFFERED SIGNIFICANT HEAD INJURY DURING THE COLLISION. HE WAS TRANSPORTED TO AN AREA HOSPITALIN CRITICAL CONDITION. THE COLLISION REMAINS UNDER INVESTIGATION BY THE NPD/OUPD CIRT TEAM.
OFFICERS RESPONDED TO A REPORT OF A FIGHT IN THE 2500 BLOCK OF W. BROOKS ST ON 10/21. A VICTIM WAS FOUND TO HAVE BEEN STABBED BY A SUSPECT MULTIPLE times. OFFICERS LOCATED THE SUSPECT AT A NEARBY BUSINESS. THE SUSPECT WAS ARRESTED AND BOOKED INTO CCDC FOR ASSAULT WITH A DANGEROUS WEAPON.
- OFFICERS RESPONDED TO A REPORT OF A SECURITY CONCERN/SUSPICIOUS INDIVIDUAL OUTSIDE OF ALCOTT MIDDLE SCHOOL ON 10/19. THE SCHOOL WAS PLACED ON A BRIEF LOCKDOWN STATUS AS OFFICERS CHECKED THE AREA AND LOCATED THE INDIVIDUAL. THE INDIVIDUAL WAS A STUDENT WHO WAS DEEMED TO NOT BE A THREAT TO SCHOOL SAFETY AFTER FURTHER INVESTIGATION BY NPD AND SCHOOL ADMINISTRATION. THE SECURE PERIMETER WAS LIFTED SHORTLY AFTER.
