



2018 City Council Candidate **Filing Requirements For Wards 2, 4, and 8**

Candidates must file at:

Cleveland County Election Board, 641 East Robinson, Suite 200

Qualifications:

Candidates must be a qualified voter in the city of Norman for six months prior to the date of the municipal election and Ward City Councilmembers must also live in the Ward at the time of filing.

Filing Date: December 18, 19, 20, 2017

Election Dates: February 13, 2018 (Municipal) & April 3, 2018 (Runoff)

In the event no candidate receives a majority of all the votes cast as the municipal election a municipal run-off will be held between the two candidates receiving the highest number of votes in each Ward.

Procedures:

- (1) Submit a written declaration of candidacy setting forth the candidate's name as he or she desires it to appear upon the ballot, address by street number, and the name of the office to become a candidate; and
- (2) Cashier's check or certified check in the **amount of \$50.00; or** in the alternative by a petition supporting the candidate's filing signed by **50 registered voters** eligible to vote for the candidate. The check shall be returned to the candidate immediately if the candidate is unopposed in the Municipal Election, receives more than fifteen percent (15%) of the total votes cast in the Municipal Election, or becomes a candidate in the Municipal Run-off Election.

Voter Registration

The deadline is January 19, 2018 to register to vote or change your registration for the February 13, 2018 municipal City Council Wards 2, 4, and 8.

If the winner of the Feb. 13 election earns a majority of the votes, that candidate will be sworn in to a two-year term as on July 3rd. If no candidate receives a majority, the two candidates with the most votes will stand in a decisive run-off election April 3.

The Council is nonpartisan and members serve part-time at the head of the City's Council-Manager form of government.

Voting Information

All Norman voters registered by the Jan. 19 deadline are eligible to vote in the municipal election Feb. 13. Use your voter ID card or the Oklahoma State Election Board's [online voter tool](#) at [ok.gov/elections](#) to find your polling location or confirm your registration.

[State law](#) requires proof of identity to vote. Acceptable forms of ID are a voter ID card, driver's license or another form of ID issued by the federal government, state government or federally recognized tribal government.
