# SIGN CONTRACTOR'S BOND

Pursuant to City of Norman ordinances, Principal has satisfied its obligation for this amount herein by providing this guarantee in the form of a:

Bond, by this Bond No. \_\_\_\_\_, by \_\_\_\_\_, as Surety duly licensed and authorized to do business in the State of Oklahoma, under which the Principal and Surety are jointly and severally, firmly held bound unto said City.

#### Now, the conditions of this obligation are such that whereas:

That the Principal has made an application for a license to carry on the business or trade of "Sign Contractor" within The City of Norman, for the period of the license paying year within said City, beginning \_\_\_\_\_\_, 20\_\_\_\_, and ending March 31, 20\_\_\_\_; and

That the Principal is bound, under and pursuant to the requirements of the Codes of said City regulating and licensing the business or occupation of "Sign Contractor" above mentioned, and in which application the Principal guarantees, upon the granting of said license, that it shall comply faithfully with the provisions of said Code in all respects and will also comply fully with all other Codes of said City affecting such business or occupation, which may now exist or which may be passed by the lawful authorities of said City during the continuation of said license, and such Codes and all other Codes of said City affecting said occupation are hereby referred to and incorporated herein and all requirements thereunder are hereby made a part of the obligations of this bond and are to be performed by the principal hereof as though fully transcribed herein; and

That the Principal will indemnify and save harmless the said City from any and all damage resulting directly or indirectly from any injury to persons or property on account of the negligence or unskilled work on the part of the principal obligor, or the agents or employees of said principal obligor.

**Now**, if the said Principal shall fully and faithfully perform all the duties appertaining to such occupation fully in accordance with the Codes herein mentioned while doing or following said business or occupation within the corporate limits of The City of Norman, and if said principal obligor shall, during the term of said license, faithfully comply with all the rules and regulations of the lawful officers of said City and with all the Codes of said City above referred to, and shall pay all fines and penalties imposed for the violation of any of said Codes, and shall indemnify and save said City harmless from any and all damage resulting directly or indirectly from any injury to persons or property on account of negligence or unskilled work of the principal obligor, or the agents or employees of said principal obligor, then this obligation shall be void and of no effect, otherwise to remain in full force and effect for the benefit of The City of Norman.
