Item 33, being:

MISCELLANEOUS DISCUSSION

Construction Site at Mercedes Drive and West Main Street. Mr. John High, 1705 Dakota Street, said there is construction at a business on the corner of Mercedes Drive and West Main Street causing the sidewalk to be blocked and deep water is running through the parking lot. He said there are no signs at the site about the problem so he called the City of Norman and asked why there are no safety measures in place. He was told that the City has problems with contractors all the time. He asked if something was going to be done to address the issue and was told the contractor had 24 hours to take care of the problem.

Anti-Abortion. Mr. Shane Dodson, Ward 8, said since he and his group had been coming to address City Council and interacting with folks in Norman, they have encountered some passionate arguments in favor of legalized abortion. He said Roe vs. Wade is not the law, but many treat this unconstitutional and unscientific court ruling as if it was codified law. He said the arguments accompanying this legalized fiction do not hold up to scrutiny. He said one objection is that it is legal and he said slavery at one time was legal also. He said another objection is that the fetus is not human although a fetus has the same biological components that everyone has. He said the only difference in an unborn baby is size, level of development, environment, and degree of dependence. He said another objection he gets is that he is a man and is discussing a woman's body. He said the body inside a woman's body is not her body. He quoted Bible scripture and said abortion is a sin that can be forgiven.

Ms. Christine Kinley, Pro-Life, said a baby in the safety of a woman's womb is being dismembered violently during an abortion. She said the baby is fighting to be saved from this and recently the United States Health Department reported that a fetus is human from the moment of conception. She said the heart starts beating 18 days after conception. She said there is forgiveness and she has learned recently that there over 100 places in Oklahoma for women who have had an abortion or girls who are pregnant and need help. She said she is a mother of an adopted child and her daughter is her world. She said there is no such thing as an unwanted child especially by an adoptive parent. She asked if Norman could become a Sanctuary City.

Ms. McKenzie Whitehead, University of Oklahoma (OU) Student, said she is a Jew and faces a lot of the issues that have been talked about regarding abortion. She provided a definition of life and said if it were not a living being in the womb it would not have to be terminated. She said our constitution does not protect the taking of a human life with the intentional mindset to do so. She provided a definition of murder and said murder occurs at the Abortion Clinic in Norman. She said it has been pointed out during these discussions that it is egregious to make similarities between the Holocaust and abortion. She said the similarities between being a Nazi and abortion go far deeper than a high body count. She hopes that the City can work on the use of deceptive language by Planned Parenthood and their use of advertisement to make it more realistic.

Mr. Gary Barksdale said in this country we all the right of free expression regardless of our viewpoints. He said City Council should hold themselves to the same standard that is expected from the citizens. He said two courageous women came tonight with signs and were told they could not hold the signs up, yet two Council meetings ago, three Councilmembers brought signs to the dais and used their official positions as elected members of the Council to hold the signs up. He said in the United States there are severe penalties for destroying eagle eggs and turtle eggs; however human children in the womb with a heartbeat, feelings and brainwave activity are being dismembered or poisoned and killed. He said certain lawmakers and government officials on this Council not only embrace this massacre but celebrate it. He said Effingham, Illinois, and Roswell, New Mexico, have both declared themselves Sanctuary cities for these helpless human beings yet to be born. He said Norman and over 580 cities nationwide are currently nearing the end of the 40 days for life. He said anything that adversely affects our citizens is a City issue and a City Council issue. He asked that Norman be declared a Sanctuary City for unborn babies.

Ms. Tammi Dodson, Ward 8, read scripture from the bible to the audience.

Ms. McKenzie Dodson, Ward 8, said every day babies are being killed at abortion clinics. She said abortion clinics are places of torture for babies. She said not only are babies killed but mothers are emotionally scarred for life. She said since City Council has the power to end abortion in Norman, please do. Miscellaneous Discussion, continued:

CART Service. Ms. McKenzie Whitehead, OU Student, asked Council to please consider continuing weekend service by CART.

Ms. Cindy Rogers, 633 Reed Avenue, reported from John High that there have been problems with CARTAccess. She said people have been calling well in advance and been put on standby not knowing if they will be picked up or not for appointments. She said CARTAccess is a high priority and even though there are budget problems, she trusts Council will look at this and see how this service can be better.

All City Band Concert. Mr. Gary Barksdale commended Norman Public Schools for the All City Band Concert held a few weeks ago at Lloyd Noble Center. He said the concert was packed full of parents and very talented young people. He said the two high school band directors did an outstanding job.

OU Debate Team. Mr. Steve Ellis, 633 Reed Avenue, said the OU Debate Team attended a Cross Examination Debate Association National Tournament in Long Beach, California last weekend. He said this was the final tournament of debate season for policy debate. He said it is a kind of an open National Championship called "the People's Tournament." He said all of the teams did well but the headline is the OU Team of Jasmine Pickens and Darius White went undefeated winning the National Championship.

Vision for Norman Election. Councilmember Holman said there was a lot of disappointment about two of the items not passing during the election. He said now Council will just have to work harder to make some decisions about continuing needed services and figure out what can be done with Stormwater. He said he was pleased that the Transportation Bonds passed and Ward Seven will benefit quite a bit from this. He said the flooding problem at Lindsey and Elm is included in this bond issue and there are three major road projects in Ward 7 adding bike lanes and sidewalks. He said he is happy that Constitution and Brooks Street is included and these are the only two streets in Norman that are at railroad crossings and do not have pedestrian crossing on either side. He said he is excited that the City will get a Traffic Control Management Center because traffic is big problem in Norman and this will help address the issue. He said he is proud of Ward 7 residents stepping up and supporting all three items.

Councilmember Hickman said the Community Planning and Transportation Committee put a lot of work into the Transportation Bond project along with City Staff. He said he wanted to acknowledge Mr. Shawn O'Leary and his staff for all the good work they did. He said there was a blended approach where some of those projects are fully funded with local dollars and leveraged with federal funds allowing the City to start sooner. He said there was considerably more investment going into central Norman with Ward Four have 3.5 projects. He said one of the projects is the Porter Corridor which will help improve accessibility with sidewalks and a new streetscape. He said the improvements will make it safer for students to cross Porter Avenue. He said there will be an extension of James Garner Avenue from the new library to Duffy Street connecting downtown and Campus Corner. Gray Street will be converted to two-way, and bike lanes will be added to Lindsey Street in the campus area.

Mayor Miller said there were three propositions that were all very important because they were about critical infrastructure needs for the community. She said Council was very happy that the Transportation Bond proposition passed; however, Council was very disappointed about Propositions 2 and 3. She said Proposition 2 was \$60 million of very needed infrastructure and Proposition 3, the Stormwater Utility, was needed for maintenance. She said Council was unable to get across the importance of these needs and these needs are not going to go away. Flooding endangers our citizens and our water quality is compromised. She said most cities pay for these infrastructure needs either through bonds or utilities. In Oklahoma, there are very few ways to pay for improvements like this and our sales tax cannot handle it. She said Council, Staff, and citizens made an enormous effort to educate our public and she personally thanked all the people who worked on this, especially the 16-member Stormwater Committee that met for over 22 months. She said Staff did an amazing job on all the literature, 30 meetings, and open houses. She thanked the Campaign Committee, the Sierra Club, the Chamber of Commerce, the Downtowners Association, and the League of Women Voters for their support. She said Council will continue to work on this.

Miscellaneous Discussion, continued:

Reaves Park. Councilmember Holman said he attended the Medieval Fair on Sunday and was approached by several people that were concerned about how building a Senior Center in Reaves Park would affect Medieval Fair and other events. He said there were also several questions about the new softball stadium at OU and whether Constitution Avenue could be realigned. He hoped to put together a meeting at the Reaves Center to discuss this.

Hate Crime/Vandalism. Councilmember Clark said there was hate crime/vandalism on Tuesday, April 2nd. She said she received pictures of it and immediately called Mr. Jud Foster, Director of Parks and Recreation, because the incident was near Lions Park. She said she was really caught off guard because she never thought something like that would happen here. She thanked all of the Councilmembers because they rallied and came together as a team and in eight hours put together a pretty good rally to send a message that we will not be intimidated or bullied. She said they struck back with love. She apologized for any insensitivity she might have made in selections of speakers due to ignorance about the Jewish faith. She said she is not afraid to admit that she was wrong and she is embarrassed by it. She said she already has a tour set up with the Schusterman Center at OU to educate herself. She said she preaches inclusivity and done her best to reach out to a lot of communities of different faiths and then realized she had a deficit in the area of knowledge about the Jewish faith.

Councilmember Hickman said the horrific hate crime happened at three locations in Ward Four. He said Hate will have no home in Norman and he asked City staff to investigate whether or not City Council can enact stronger hate ordinances in Norman for enforcement purposes.

Councilmember Bierman said she was close to Lion's Park when she got word of the incident and immediately drove to the site and was dumbstruck. She was very upset and then she got mad; then she decided to go to work. She said the Democratic Party Headquarters had extensive damage and was difficult to clean. She organized a clean up with at least 15 volunteers coming to help. She said in two hours it was clean. She said the rally was very healing even though it was not perfect because it is hard to put something like that together in such a short time. She said when she put out the post for help, that post was shared more than 9,500 times and along with that came a very difficult crash course in White Nationalist lingo. She said there many, many private messages she received which were hateful, vile, ant-sematic, racist, and misogynistic. She said she is working on some ways that residents can become better versed in this type of behavior so it can be recognized and faced head on.
