Sec. 18-402 Permanent signs require ID plate (contractor, date, permit #, amps) Sec. 18-304 Upon expiration of a temporary sign, all related structural materials must be removed for no less than the length of time of the original permit, no additional temporary sign permits will be issued during this period of time. 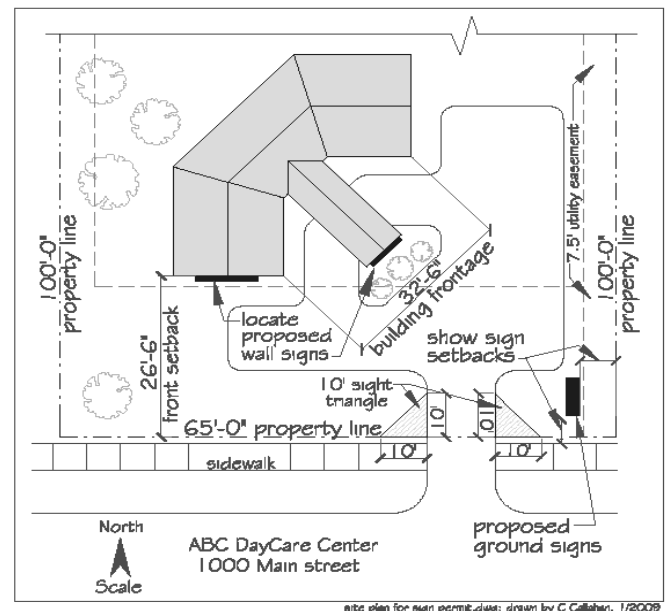
