



February 2015 CARTaccess Total Ridership




July 2014 - February 2015 (Year-to-Date FY15) CARTaccess Total Ridership



Community Planning & Transportation Committee CART Monthly Report, February 2015

Ridership Report Summary CART

- CART transported 103,592 riders in February -- an average of 4,878 riders daily. Ridership for February 2015 was up 7% over February 2014.
- FY15 year to date (July 2014 February 2015), CART transported 671,349 riders an increase of 4% over the same period in FY14 (July 2013 February 2014).
- Ridership is up on Lindsey East and West, Sooner Express, Research, and LNC.
- During the week of February 23-28, 310 CART riders traveled with their bicycles (1.3% of all trips) and 29 using wheelchairs (.01%). This count was down considerably due to the inclement weather during this week. Lindsey East (98), Lloyd Noble (54), and Main Street (52) carried the most bicycles. Main (14), Lindsey West (7), and Alameda (6) transported the most riders with wheelchairs.

CARTaccess

- CART transported 2,742 CARTaccess riders in February an average of 114 riders daily. This is an increase of 8% for the month and 4% year to date.
- Since January, approximately 30 CARTaccess riders have requested CART ID cards to ride free on the fixed route system.

Marketing/Outreach efforts

- "Turn Up for Transit" event will be held Wednesday, March 25 on the OU South Oval to promote alternative transportation, including CART, bicycling, and ride sharing.
- CART continues to promote its extended service til 10 pm and free fare for CARTaccess riders on fixed route service.
- CART is planning an event for April 9, Stand Up 4 Transportation Day and will send an invitation to Norman City Council before the end of March.

Grant Activity

New Bicycle Repair Stations and Bicycle Racks (Air Quality Awareness grant) – 15 bicycle racks is groups of five have been installed at three locations: Headington Hall, Huffman Center, and the Brooks St. Station. Bicycle repair stations will be installed at Brooks St. Station, the Lloyd Noble Center, and the Norman City Library.

Fixed Route vehicles (FTA 5307 and Clean Air grants) – 2 new 35' CNG Gillig buses are scheduled to arrive in July.

Regional Planning Activities

- Attended the Oklahoma Transit Association winter conference February 4-6 in Oklahoma City
- Attended the ODOT Civil Rights conference on February 28 in Norman
- Working with ACOG on its long range transit planning efforts for Encompass 2040.

streets - Approval of Bus Wrap Design

The Congestion Mitigation and Air Quality Improvement Program (CMAQ) was created under the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991, and reauthorized under the Transportation Equity Act for the 21st Century (TEA-21), the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), and, most recently, the Moving Ahead for Progress in the 21st Century Act (MAP-21). Through Fiscal Year (FY) 2012, the CMAQ program has supported nearly 28,000 transportation projects across the country, accounting for nearly \$30 billion in transportation investments since its inception in 1992.

The purpose of the CMAQ program is to fund transportation projects or programs that will contribute to attainment or maintenance of the National Ambient Air Quality Standards (NAAQS) for ozone, carbon monoxide (CO), and particulate matter (both PM10 and PM 2.5).

As part of a one-year pilot program in the Oklahoma City metropolitan area, the Association of Central Oklahoma Governments (ACOG) made Air Quality Awareness Grants available to eligible applicants. A minimum of \$75,000 in CMAQ funds were available for small active transportation infrastructure projects and public education programs that serve to improve and enhance awareness of Central Oklahoma's air quality.

Eligibility was limited to city governments, county governments, public schools, public school districts, public universities and tribal governments. Air Quality Awareness Grants require a minimum of 20% in matching local funds (in-kind is not accepted) and awards will be conferred as reimbursement. No single entity can receive more than 56% of the total grant award amount. ACOG reserves the right to negotiate grant awards and agreements.

The City's Bicycle Advisory Committee identified a public education program compatible with the Air Quality Awareness Grant Program and asked staff to explore the possibility of making an application for funding. The program is intended to serve as a public safety campaign to raise awareness of bicyclists riding on City of Norman roadways. The goal is to develop a safer riding environment for bicyclists and to encourage more people to use their bicycles as a basic means of transportation. The campaign is designed to utilize a special bus wrap installed on one of the buses operated by CART. The message on the wrap will have information that reminds motor vehicle operators that bicyclists have the right to occupy part of the roadway.

Staff discussed the grant opportunity with CART and obtained a cost estimate for the fabrication of the wrap (\$575.00) as well as the annual cost of displaying the message as an advertisement mounted on the back of one of their buses (\$6,000 for a twelve-month period), for a total of \$6,575.00. During those discussions, CART officials also agreed to fund 50% of the local grant match, or \$657.50, with the City of Norman providing the other 50%.

An application was prepared by staff and submitted to ACOG in April of 2014, requesting a grant to fund the program. The request was reviewed and approved and ACOG offered \$5,260 in CMAQ federal funds to pay for 80% of the program's cost. ACOG staff also requested that the City approve contract K-1415-47, which describes the program and enumerates the conditions the City will need to comply with in order to receive the funds. The contract was approved by City Council on October 14, 2014.

Since then, the BAC has worked with City staff and other volunteers to develop the bus wrap design. During the BAC's meetings of October 13, 2014 and November 10, 2014, members agreed on the general concept of the design (see attached minutes of the meeting). The final concept is consistent with those recommendations and concurrence from the Community Planning and Transportation Committee of the Council is requested in order to move forward with fabrication.



- No multimodal path included inconsistent with the Norman Comp plan
- Only meeting to give input on the design of the cross-sections

Dispute/Discussion with ODOT:

- Trying to restrict driveway access the 5-lane ('paved median') is essentially encouraging turning movements that were not recommended by Norman.
- Norman City Council adopted a resolution for including a bicycle path
- ODOT would not include the bicycle path in the project but would be ok if
 enhancement money to construct; ODOT won't give ROW for the bicycle path
 within the extensive ROW that is already available that should be included in the
 project (ROW should be useable for the future design and construction bicycle
 path; without that concession creating the bicycle path will be effectively
 impossible)
