UPDATE OF CLOSED SECTION LINE ROADS NOT ELIGIBLE FOR BUILDING PERMITS.

**SUBJECT:** Update of Closed Section Line Roads Resolution R-0405-64

**BACKGROUND:** In September of 1985, City Council adopted Resolution R-8485-53, as recommended by the Rural Area Plan Committee. The Plan Committee was concerned about the issuance of building permits on section line roads that had never been property constructed and had not been accepted by City Council. That resolution officially designated numerous section line roads throughout Norman as "closed" due to the fact they had never been properly constructed and accepted by the City. Properties adjacent to those section line roads designated by that resolution as closed were not eligible for issuance of a building permit without specific exceptions.

Since the adoption of Resolution R-8485-53, Council adopted the NORMAN 2025 Plan and with that adoption staff updated the requirements to qualify for a building permit with Resolution R-0405-64 to include a minimum requirement of 40 acres to qualify for building permit as well as updating the roads now open.

<u>DISCUSSION:</u> Since the adoption of Resolution R-0405-53 several of the previously closed roads have opened. In addition, staff recognizes that since the minimum requirement for acreage in the A-2, Rural Agricultural District is 10 acres, or smaller if the tract is a legally filed of record tract of land, that the previous requirement of 40 acres to qualify for building permit is not appropriate and prohibits land owners from building on legally subdivided lots if they cannot meet the 40-acre minimum.

Language in Resolution R-0405-64 stated "whether a public road has been adequately constructed to public road standards on said section lines and whether said pubic roads have been accepted by the City." There are several roads now open that are not constructed to public road standards and staff cannot determine that they have been accepted by the City. Therefore, staff has amended the language in the Resolution to allow for the fact that existing section line roads may exist that are not built to a City standards but are an acceptable access to properties.

**RECOMMENDATION:** Staff recommends adoption of the updated Resolution, removing the open roads from the previous list, declaring certain section line roads as closed and allow for development on legal lots of record.

A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA, DECLARING CERTAIN SPECIFIED SECTION LINES AS NOT ELIGIBLE FOR BUILDING PERMITS EXCEPT AS PROVIDED HEREIN.

- § 1. WHEREAS, the statutory section line was established for the purpose of providing public road access to individual tracts of land; and
- § 2. WHEREAS, the granting of building permits for properties abutting section lines are dependent upon whether a public road has been adequately constructed to public road standards on said section lines; and
- § 3. WHEREAS, concern has been expressed regarding which section line roads are open and available for safe travel; and
- § 4. WHEREAS, the section lines described in Attachment A are not open and available for safe travel.

# NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA:

- § 5. That said section lines described in Attachment A shall not qualify as public road frontage as required by City Code for land subdivision or for the issuance of building permits; and
- § 6. That tracts abutting said section lines shall not be issued building permits unless the section line road is constructed to acceptable standards or served by an alternate street or roadway as prescribed by Chapter 19 of the Code of the City of Norman; and
- § 7. That said section line rights-of-way are not abandoned by this action; and
- § 8. That the City Council of the City of Norman maintains its authority to revise this policy; and

Beginning at a point 3,030 feet west of 12th Avenue East, thence west to the

Norman City limits line.

Imhoff Road East: Beginning at a point 2,640 feet west of the Indian Meridian (132<sup>nd</sup> Avenue East),

thence west to the boundary of the LRSP.

Between 144<sup>th</sup> Avenue East and 156<sup>th</sup> Avenue East.

From 168<sup>th</sup> Avenue East to .4 miles west of 180<sup>th</sup> Avenue East.

Robinson Street West: Beginning at a point 3,960 feet west of 60<sup>th</sup> Avenue West, thence west 1,320 feet

to 72<sup>nd</sup> Avenue West.

Main Street West: Beginning at a point 3,168 feet west of 48<sup>th</sup> Avenue West, thence west to the

Norman City limits line.

Rock Creek Road East: Between 84<sup>th</sup> Avenue East and 108<sup>th</sup> Avenue East.

Beginning on 120<sup>th</sup> Avenue East, thence east to a point 2,640 feet west of 156<sup>th</sup>

Avenue East.

Rock Creek Road West: Between State Highway No. 77 and 24th Avenue NW. Interstate 35.

Tecumseh Road East: Between Porter Avenue and 12<sup>th</sup> Avenue East.

Between 72<sup>nd</sup> Avenue East and 84<sup>th</sup> Avenue East.

Between 132<sup>nd</sup> Avenue East and 144<sup>th</sup> Avenue East.

Indian Hills Road East: Between 84<sup>th</sup> Avenue East and 98<sup>th</sup> Avenue East.

Beginning on 108th Avenue East, thence east 3,960 feet.

Beginning at a point 2,640 feet west of 144<sup>th</sup> Avenue East, thence west to a point

4,000 feet east of 120<sup>th</sup> Avenue East.

Bethel Road East: Beginning on 72<sup>nd</sup> Avenue East, thence east 1,320 feet.

Between 84<sup>th</sup> Avenue East and 96<sup>th</sup> Avenue East.

Beginning at a point 2,640 feet west of 120<sup>th</sup> Avenue East, thence east to 144<sup>th</sup>

Avenue East.

Friendship Road East: Beginning on 144<sup>th</sup> Avenue East, thence west 3,960 feet.

Little River State Park: All section lines within the Little River State Park are closed with respect to

obtaining building permits from the City of Norman.
