Animal Welfare Oversight Committee

February 12, 2018

The Norman Animal Welfare Oversight Committee of the City of Norman, Cleveland County, State of Oklahoma, met in the multi-Purpose room on the 12th of February, 2018, at 6:00PM. The notice and the agenda of the meeting were posted in the Norman Animal Welfare Center building at 3428 S. Jenkins on the 7th of February, 2018. The meeting was also posted on the City of Norman website at www.normanok.gov.

I. Call to Order

Co-Chairperson Mark Howery called the meeting to order at approximately 6:02 PM.

III. Discussion and Approval of the January Minutes

There were some grammatical errors corrected in the minutes. A motion to accept the minutes as amended was made by Bill Hickman. Jennifer Kidney seconded. The motion passed.

IV. Monthly Statistics and Division Updates

Captain Barbour briefly went over the January statistics. Owner surrenders continue to be up from last year. Protective custody numbers were up by 1250%. These animals are usually in the shelter for a much longer stay than normal stray intakes.

Bill Hickman asked if Protective Custody cases are kept on the intake side. Captain Barbour said yes, and if they are friendly, you might see some up front in the office occasionally.

The average length of stay statistic does include the shelter's protective custody cases. Captain Barbour also said that the current Owner Surrender list has been resolved, and adoptions and reclaimed animals are still significantly high, as well as the monthly live release rate.

Co-Chairperson Mark Howery commented that January has been the third month in a row that there have been relatively high numbers of cats reclaimed.

Captain Barbour said that the last Animal Welfare Tech has been hired and has been at the shelter for a couple of weeks. There will be a focus on training all of the new additions to the staff. Mark Bechtel has taken over operations at the shelter; Captain Barbour will still be in and out of the shelter until July.

Bill Hickman asked about the carport project being on hold. Captain Barbour explained that it is on hold, pending a request for a pavement project that would extend the parking lot. If approved, then the carport location would move. Captain Barbour reminded everyone that Capital Improvement Projects are not tied to a fiscal year, so that funding will not be lost.

Bill Hickman asked about the fifteen dogs that were euthanized for behavioral issues and if there was an evaluation protocol in place. Captain Barbour said there's no checklist of behavioral issues, but in some cases, several people evaluate these dogs before they are euthanized. Some of these dogs are made available to rescues if the rescues are comfortable taking them.

Dr. Tyler does a write up of each euthanasia performed.

Mark Howery spoke about the changing public perceptions of Norman Animal Welfare and said he thinks that there are more people who are comfortable bringing their animals here to be owner surrendered.

Rebecca Bean asked if there was an advantage to keeping the adoption trailer where it was and reallocating the funds for the carport. Captain Barbour said that currently only three sides are covered and protected from weather and Capital Improvement Project funds can't be reallocated; instead, they would go back into the general fund.

Rebecca Bean asked if anyone knew what was raised at the Rob Lake Magic Show over the weekend. Captain Barbour said he didn't know yet.

V. Old Business Updates and Follow-Ups

Captain Barbour said that updating Petfinder with the current stray animals has been done on Shelter Buddy's end, but Petfinder has been having technical issues and strays are still not showing up on the site.

Rebecca Bean asked about a photo album for strays on Facebook. Captain Barbour said it would take up a lot of resources to keep it current and answering people's questions/comments. It's not completely off the table if Petfinder does not start showing the strays.

VI. NAWC Budget Update

Captain Barbour provided a list of budget requests that is not provided in the packet as it is still subject to change. The items have been submitted and are awaiting approval.

Bill Hickman asked if the list was in any priority order. Captain Barbour said the Registered Vet Tech was the priority, then the camera and keycard systems for security reasons.

Rebecca Bean asked how a keycard system would work with the volunteers who come regularly and help in back intake areas. Captain Barbour said it would depend on the system. There might be a check in and they would receive a keycard, or else the Center would be kept unlocked during business hours.

Co-Chairperson Mark Howery asked about the outdoor run project. Captain Barbour said it would be for animals that are at the shelter for long term reasons, such as protective custody or similar situations. The animals could be taken outside but still be kept away from the public.

Captain Barbour spoke about the incinerators that need to be replaced. One has been in use for 25 years, and the other is about 16 years old. They've both been refurbished and continue to be fixed when they break down. A typical lifespan on an incinerator is six to eight years. It costs thousands to have a technician come out

and repair them; they break down several times a year. The cost of a new one is around \$100,000 and an additional \$50,000 for installation.

The requested increase for the food account is to help cover the costs of food for foster animals.

The maintenance account request refers to the facility maintenance. We are already seeing wear and tear on the two-year-old building. There are kennels in which the floor and wall are already separating. We continue to have HVAC issues that require constant maintenance during the summer and winter. The food prep room cabinetry is becoming affected by the steam from the dishwasher and the fact that the door doesn't close properly.

Co-Chair Rebecca Bean asked if there was a way to get an idea of the cost of fixing the HVAC problems so that we can begin to ask for that amount.

Captain Barbour said he didn't know what would need to be done to fix the problems or have an estimate of the cost.

Bill Hickman clarified that these budget requests will go to the Chief of Police first, then the city Manager, and then finally before City Council. He explained that the items on this list might not all make it to be voted on by City Council.

Rebecca Bean made a motion for the committee to write a letter of recommendation for the approval of the budget requests. Sandy Moore-Furneaux seconded. The motion passed.

VII. Updated Procedure for Private Traps

Currently there are two processes for wildlife. Citizens can rent a trap at no cost for seven days, dependent on the weather. If they trap something, they can bring it to the Center or officers can pick it up at their home. Then it is taken to Wildcare or it is brought to the shelter and Wildcare is called so that their volunteers can pick up the animal. Private traps are also picked up by officers and can also be brought in by citizens. The problem with this system is that animals are waiting for quite some time before being picked up during the day. Also, we have had some citizens who do not check in at the office but drop off animals in the back that remain unknown to office staff. Beyond that, there are logistical and liability issues involved with taking the private property of citizens and storing it at the shelter, sometimes keeping traps until the owners need them again in several months. At this time, there are

between thirty and forty privately owned traps that are stacked for which the City is responsible for keeping, maintaining, and eventually returning back to their owners. It is an ongoing project to return these traps to their rightful owners.

Captain Barbour said that after having talked with Rondi Large at Wildcare, there will be some changes made in the next month.

The first change will be education-based. There will be a push to educate the public about humanely trapping and the risks versus the rewards.

Those privately owned traps will also now be taken by the citizen straight to Wildcare. They have longer hours than the Center does, and the animal will be going straight to them.

We will still accept traps that are owned by the City of Norman.

Rebecca Bean asked why Norman Animal Welfare is renting out traps. She referenced the meeting with ASPCA members last year who were surprised that we offered the service at all. She knows that many communities are trying to get away from that service from the perspective of wildlife management, and she said there's a large burden being placed on Wildcare.

Captain Barbour said that internally there is a push to end that service. Eventually, ending this service completely would be a goal.

Rebecca Bean asked if Rondi Large had any comments at this time.

Rondi spoke about not wanting wildlife trapped and relocated at all as this creates vacuums and just causes animals to move back to their original location and not solve any problems. She expressed concern that citizens who don't have the resources to have the traps picked up will just let the animal die in the trap. She said she would be interested to know the numbers of traps being brought in versus those being picked up.

Officer Trey Amrein said that he thinks most weeks it's about 50/50 traps picked up vs. brought to us.

Captain Barbour said there will be language included in the educational component of this change that specifies that it is animal cruelty not to care for the trapped animal.

Officer Trey Amrein said that, in his experience over the years, citizens do call in when they see a neighbor who has trapped an animal that they're leaving in the trap.

Kristy Wicker commented that it seems as if there will need to be a big educational part of the process from both the City and from Wildcare. And it's important for people to realize that animal cruelty charges can include wildlife.

Captain Barbour said it will be a large push, and we will utilize *The Transcript*, social media, and press releases. The aim is to start this change by March 1st.

There was a brief discussion on wildlife education and resources.

Co-Chairperson Mark Howery said the USDA wildlife division offers a species by species manual that includes lethal and non-lethal deterrents.

Rondi Large said that HSUS also has a wildlife section about humanely dealing with wildlife.

VIII. Updated Procedure for CPL and Rabies Citations

Captain Barbour said that intake numbers and reclaimed animal numbers are increasing. There is always a discussion of the punitive nature of reclaiming one's animal and success in encouraging people to contain their animals versus coming in and paying to reclaim their animal.

Starting in the near future, when the shelter has a repeat offender come through the door, if they say they don't have the money to pay to get the animal out, staff will still work with them on the fee, but if they don't have their rabies vaccination or City pet license, the Center will be more strict. Office staff will now issue citations for lack of rabies vaccination and lack of City pet license.

Proof of a rabies vaccination is required for a City pet license. For a Norman resident who receives a citation for lacking a City pet license, as long as they return within five days and show proof of a City pet license (which means they are also current on their rabies vaccine), it will only cost them their time. There will be no court fees or fines applied. If they live outside of Norman city limits, they are still required to have a rabies vaccination and will get a citation if they don't have one. In that case, they will need to bring in proof of a rabies vaccination and there will be a small fine of \$55.00.

Jeanne Snider said that they were a bit more strict on vaccinations as opposed to City licenses and that a fee is always charged.

The big change internally at the Center is that Animal Welfare Techs will be trained to fill out the docket and issue citations.

Sereta Wilson asked if it could be mandatory to spay or neuter dogs.

There was a discussion on what other cities do that require spaying and neutering before an animal can be reclaimed.

Dr. Tyler brought up the possibility of vaccinating the repeat offender animal before letting it return to its owner.

Jennifer Kidney asked if the City licenses had arrived. They are in at Norman Animal Welfare and participating vet clinics.

IX. Shelter Assistance Fund Update

Sereta Wilson presented the update for Annie's Rescue Fund. She gave background on the organization and the board that was created to administer the fund. Their meetings occur on the second Sunday of each month at Annie's Ruff House. Usually requests to use funds are made through the Center veterinarian Dr. Tyler.

So far, \$24,000 has been raised between the two funds, and \$5965 has been spent. Sereta Wilson went over the items paid for in 2017 that were recorded in the January minutes.

Dr. Tyler talked about a couple of specific cases for which the money was spent to help animals at the Center.

The recent funds raised by the Rob Lake show in February will go to the City donation account. Captain Barbour said this was a decision made by those who coordinated the event, including Dr. Otto. The funds raised by the show will not go to supplement general medical costs but for items above and beyond what the Center would normally cover.

Jennifer Kidney commented that there would be a public accounting of the spending from this event because it will be for a "big ticket" item that must be approved by City Council.

Sereta Wilson spoke about continuing fundraising for the Norman Animal Welfare Fund and said that there is support for that in the community.

Rebecca Bean said she would like to see a future agenda item of a wish list for items that the staff would like to see the money used for.

One possible use of the funds would be for the purchase of an x-ray machine. Dr. Tyler commented that there was actually an x-ray room built into the new Center that is currently being used as a closet

X. Call for Agenda Items for Next Meeting

Bill Hickman said that a future agenda item should be a revisit of Animal Welfare ordinances.

Co-Chairperson Mark Howery wanted to gauge who would be present in March for the meeting.

Rebecca Bean said that Ginger Noble had decided to step down from the committee to focus on other initiatives.

Sandy-Moore- Furneaux made a motion to cancel the March Meeting. Jennifer Kidney seconded. Motion Passed.

Co-Chairperson Mark Howery said he encouraged everyone to attend the Animal Welfare Expo on March 24th.

XI. Miscellaneous Comments

Kim Fairbanks commented that heartworm positive dogs in the past have sometimes been treated through fostering. She also talked about the Animal Welfare Expo that will be held at the Cleveland County Fairgrounds on March 24th. There will be a kitten fostering workshop presented by Hannah Shaw, the "Kitten Lady." There are already over 200 people registered for the workshop. She also mentioned that Weaver the cat raised over \$1,000 for foster kits on his birthday.

XII. Adjournment

Co-Chairperson Mark Howery called for a motion to adjourn the meeting at approximately 8:05 PM. Jennifer Kidney moved to adjourn. Kristy Wicker seconded. The motion carried, the meeting was adjourned.

City of Norman Animal Welfare Updates and Information

February & March 2018

Employee Updates:

- Division remains at full staffing levels. We continue with the significant process of employee development and training. While this transitional period has created a great opportunity for continued growth and new ideas that truly paint an amazing picture for the future of our team, facility, and community involvement, things will be a bit slow as we continue to cover foundational aspects of our culture and function.
- AWO Baskeyfield was recognized for 40+ years of service to our department and community.

Activities and Events:

- \$10 Adoption Special (Feb 27 to March 3) – 20 dogs and 9 cats adopted in four days!
- Free Adoption Special (March 10 & 12) – 25 dogs and 14 cats adopted in two days!
- Animal Welfare Expo (March 24) - 12 dog adoptions and 94 microchips implanted
- **Dogs Helping Dogs III – April 21st at the Norman Dog Park**
- **Crimson Wishes Adoption Event - April 27th at the Lloyd Noble Center**

Other Items:

- Preliminary assessment and review of ordinances is ongoing. This is a process that will take some time to complete. Work will continue to produce proposals that will be provided to the committee for review followed by public meetings set specifically for public discussion and input before any suggested changes being considered for adoption.
- Two cats that tested positive for feline leukemia were transferred to Austin Pets Alive for participation in a part of a long-term study on feline leukemia.

Capital Improvement Items

- Shade Screens: New concerns in place about ice. Looking at options for future coverings.
- Carport for Trailer: On hold pending other CIP requests.
