UNP TIF OVERSIGHT COMMITTEE MINUTES

May 21, 2007

The University North Park Tax Increment Financing District ("UNP TIF") Oversight Committee met at 11:30 a.m. in the Municipal Building Study Session Room on the 21st day of May, 2007. This was the first meeting of the committee.

Anthony Francisco, Finance Director, started the meeting by extending a welcome to the newly appointed committee members. He then gave a brief history of the UNP TIF describing the progression of the area from a former navel base during WWII through creation of the TIF.

Kathryn Walker, Assistant City Attorney II gave a presentation (a copy is attached) covering the TIF legal agreements. The presentation was brief and highlighted each agreement.

Sharon Parker and Gail Poole both asked about the status of Development Agreement #3 concerning Legacy Park. Jeff Bryant, City Attorney, commented that it is currently being drafted but is not finished at this time.

Lynne Miller inquired as to the completion date for the hotel and conference center. Jeff Bryant noted that it is scheduled to be completed in August 2008. Jeff Bryant also commented that the original plan was to have a different bond issuance for both the roadway improvements (and start-up activities) and Legacy Park but the plan now is to combine these two together in one issuance. This will save money in the long-term and is needed due to the faster than expected development of Legacy Park.

Anthony Francisco provided more detail to the committee regarding the OU Foundation's guarantee of the first TIF bonds (roadway & initial startup activities and Legacy Park). He also highlighted the TIF cap limit and commented that the developer will be responsible for any overages above the cap limit.

Joe Siano asked about the funding for the proposed Rock Creek Street bridge. Anthony Francisco and Jeff Bryant provided information about the proposed project which is not included in the UNP TIF. They noted that the bridge is estimated to cost \$13 million and that the State of Oklahoma has pledged \$4 million at this point.

Shawn O'Leary, Director of Public Works, gave a presentation (a copy is attached) regarding planned TIF traffic improvements.

Gail Poole asked about the design status of the Rock Creek Street bridge and commented that he would like to see a pedestrian walkway included in the design. Shawn O'Leary commented that design has not been completed at this time but felt a pedestrian walkway was a good idea.

Gail Poole also asked about plans for light rail service that was discussed at various stages of the TIF development. Anthony Francisco noted that easements in the north part of the TIF have been planned that will allow for light rail.

Joe Siano asked about one option being discussed to fund the Rock Creek Street bridge, namely using an assessment district. Anthony Francisco, Jeff Bryant and Shawn O'Leary provided opinions on how this would work. At this point, it is purely speculation.

Robert Castleberry asked about the purpose of the committee. Anthony Francisco read from City Council Resolution R-0607-95. A discussion ensued as to the committee's purpose and responsibilities.

The committee elected Robert Castleberry as Chair and Sharon Parker as Vice Chair. Future meeting dates will be determined on an as needed basis. The 2nd Monday of the month at 11:30 was agreed to be the best fit. The committee is required to report to Council at least annually. It was decided that the fall would be the best time but is not set in stone.

The meeting was adjourned by Chairman Robert Castleberry at approximately 1:10 p.m.
