The meeting was called to order by Chairman Castleberry at approximately 11:50. A motion was made to approve the February, 11, 2008; May 27, 2008; and June 4, 2008 minutes. A second was received with no discussion following. The motion passed.

Anthony Francisco, Finance Director, provided a recap of the June 5, 2008 special council meeting that addressed Development Agreement #4 and the proposed 1st financing package. The main point of dissension related to how the TIF Project Plan reallocation of conference center (\$15 million) amounts relate to the roadway cap of \$11.55 million if used to partially fund the Rock Creek Overpass project. Kathryn Walker, Assistant City Attorney, provided more information regarding their office's position regarding these matters. Handouts were provided related to relevant portions of the UNP TIF Project Plan and Levels of Traffic Service at various intersections if the Rock Creek Overpass were to be constructed. Discussion ensued. The overall concern of the Committee related to amending the Project Plan and the concern for making amendments beyond those related to the Rock Creek Overpass.

The Committee drafted a recommendation (see attached) to the Council sub-committee drafting changes to the Project Plan. A vote was taken regarding the written recommendation. Robert Castleberry, Ted Greb, Joe Siano, Gail Poole* and Karla Bonzie voted for the recommendation as written.

The meeting was closed at approximately 12:40.

* - Gail Poole subsequently changed his vote to no. He does not support a bridge unless it has 4 lanes, plus a bike/passenger path and enough space additionally for a trolley track as well as exit lanes for both north and south traffic.

The Committee appreciates the opportunity to serve Council and hopes that the above comments will be beneficial to Council's decision to revise the Project Plan.
