B. Urban Mountain Biking Trail System (Tobin, Alica, Gary)

Tobin has been in contact with the International Mountain Biking Association (IMBA) and has a meeting scheduled for October 16 with Chris Burnheart and Hans Johnston, both from IMBA. Tobin stated that IMBA has a trails building guide that can be used as a resource. IMBA offered to map Ruby Grant Park via GPS. There was some discussion that we move away from the name "mountain biking trails" and more toward just "trail system." James brought up the "Storm Water Master Plan." James distributed a map showing a city owned area which is the SW corner of Lindsey St. and East 24th Ave (see Figure 1) as well as a map of John H. Saxon area which is the SW corner of SH 9 and East 36th (see Figure 2) which currently contains a 1K and a 2K running trail, both as possible mountain biking trails opportunities.. James also mentioned the Falls Lakeview Park, http://www.ci.norman.ok.us/parks/falls-lakeview-park, at 3280 108th Ave NE just south of Tecumseh, and the privately owned land by the river as mountain bike trail opportunities. There was some discussion about the minimal size requirements for a mountain bike trail system. Tobin was to organize a "tour-of-Norman site survey" for possible trail system locations. James also mentioned a resource, the Oklahoma Tourism and Recreation Depart Grant Information, http://www.otrd.state.ok.us/rd/Grant%20Main.htm, which provide matching funds.

Everyone was reminded that a very important (to the cycling community) City of Norman Council Meeting on October 12, 2010 in which resolution No. R-1011-55, "A RESOLUTION OF THE COUNCIL OF THE CITY OF NORMAN, OKLAHOMA ADOPTIGN THE REVISED NORMAN BIKE ROUTE MAP RECOMMENDED BY THE NORMAN BICYCLE ADVISORY COMMITTEE" will have a motion to adopt or reject. This translates to the BAC proposed trial bike lane re-striping project program being approved. BAC members where recommended to attend. Also in this meeting, a City of Norman ordinance of the three-foot passing rule (mirroring the current state law) was to be proposed.
