Item 6, being:

DISCUSSION WITH CARLA KIMBERLING OF NORMAN PUBLIC SCHOOLS REGARDING THE NATIVE AMERICAN TASK FORCE.

Carla Kimberling of the Norman Public Schools informed the Commission about the changes that had been made to the curriculum and activities surrounding the land run in Oklahoma. The task force worked with the Chickasaw Nation to develop activities that were based on educational information regarding the land run and that period of time in Oklahoma. Norman Public Schools will no longer be reenacting the land run.

Item 7, being:

DISCUSSION OF ADDITION OF SEXUAL ORIENTATION AND GENDER IDENTITY AS A PROTECTED CLASS IN THE CITY OF NORMAN PERSONNEL MANUAL WITH RICK KNIGHTON, ASSISTANT CITY ATTORNEY.

Rick Knighton submitted suggested changes to the City of Norman Personnel Manual focusing on emphasizing that all employment decisions would be based on "merit only" principles. Mr. Knighton stated that by emphasizing "merit only" principles, there was less need to list individual classes of exemptions.

Commissioner Ham stated that she was not happy with this. She understood where the City was trying to go, but this language did not really address the issue.

Commissioner Schmidt stated that several other cities in Oklahoma including Tulsa had included the terms sexual orientation and gender identity in their documents and that was what the Commission would like to see. She stated that discrimination based on sexual orientation and gender identity was not limited to hiring and firing. It could happen at any time during a person's career from training opportunities to job assignments. If there was a protected class, employees who were being discriminated against might be more likely to report it.

Commissioner Wattley stated that this issue needed more discussion and suggested that Mr. Knighton take the recommendations from the Commission under consideration and the Commission will discuss this issue further at the October meeting.

Item 8 being:

MISCELLANEOUS DISCUSSION.

Commissioner Schmidt asked if the Commission might be interested in pursuing an Inclusive Community discussion with the Muslim community in Norman. With the construction of the new mosque nearing completion, this might be a good time to engage the community in discussion.

Commission Seirafi-Pour stated that this was an excellent suggestion and she was positive that the Muslim community would welcome this type of activity.

There was also discussion of the Mayor's annual Iftar dinner that will be held sometime in August.

Commissioner Drywater related an experience she had with a young woman at the Women's Domestic shelter. She said the young woman had been assaulted by her husband and when the Norman Police Department arrived, she felt as if they ignored her. She also stated that a Norman Police Officer acted as if he was not aware that Norman had a domestic shelter for women.

Aimee Rook addressed the Commission about an upcoming movie "Project Nim" that focuses on activities in Norman and the University of Oklahoma in the 1970's. She hopes that citizens of Norman will embrace this project and see the story for the lessons it teaches.
