A motion was made and seconded to approve the August 21, 2012 minutes. No changes were suggested and the motion passed unanimously.

Anthony Francisco provided an update on projects.

- He attended the grand opening of the Valliance Bank recently and said it was a very nice facility.
- Bank officials offered the meeting facilities for City business use.
- UNP Project Update map prepared by the Public Works Department was handed out.
- Looking at plat for Crest Foods store
- Ezzell When will bids for Legacy Park construction be let?
- Mid-November and go to Council on December 11, 2012 for awarding of contract.
- Plan to be filed tomorrow.

Kathryn Walker provided Update on Economic Development.

- New TIF generated sales tax is \$19,321,236 includes adjustment.
- Total ad valorem tax through 2011 assessment year is \$5,229,389 division is 60% to TIF #2 and 40% to General Fund does not think it includes sale to Inland.
- NEDC will purchase within the next 30 days the remaining 30 acres of Economic Development Land same financing structure of 1st 30 acres purchased in October 2010.
- Timeline of TIF Development
 - Future Lifestyle Center and Legacy Park
 - General Development Funds \$8.25 million dollars to be used to foster special employment.

- 10% sales tax 40% to General Fund and 50% to other 10% goes to economic development.
- City is partner with Economic Development Coalition.
- First 20 acres was to establish an advanced manufacturing center.
- NEDC has received a grant of \$2.5 million dollars to help with these projects.
- Nebulus Aerospace Company to use 1 lot of advanced industrial sites- which is 5 6 acres and an option on second site.
- Total of 6 lots available.

Anthony Francisco made presentation on Update on Revenues and Expenditures. Handout of expense and revenue reports prepared by Suzanne Krohmer and Clint Mercer

- Legacy Park expenditures showing in FYE 13 expenses column.
- \$600,000 remaining balance
- Ezzell would like to see UNP TIF receipts showing what's in the bank and what we have for economic development available.
- \$1.8 million \$600,000 and \$425,000

Miscellaneous discussion – next month we'll have additional special information from Council's October 23rd meeting.

Currently pushing a plat behind Kohl's store – zoning is done.

Gail - south of Sooner Mall - a lot of vacancies along Ed Noble Parkway - probably makes a bad impression on people driving on I-35.
