PRESENTATION BY STAFF

Mr. Stenis reviewed the staff report, a copy of which is filed with the minutes. There were no filed protests on this application.

Mr. Ryan asked about the size of the sign. Mr. Stenis responded that the proposed sign would be in compliance with the sign area regulations. It is proposed to be 96 square feet and 100 square feet is allowed. The sign qualifies for a permit except for the setback.

PRESENTATION BY THE APPLICANT

Ron Nealis, Signs & Neon, Inc., representing the applicant – We have done everything, I think, that has been required to the best of our knowledge. When we started this, it was originally approved to go in the island on the plans. It was in an easement; we had to go through all the utilities and got their approval and went to the City board and got that approval. This is the last step before we put the sign up, to the best of my knowledge.

Mr. Ryan commented that the sign placement seems to be written in on the plans. The fact that the site plan was approved is something different from the sign placement.

Derrin Bollinger, Affordable Construction – I'm the superintendent on the job and it was actually approved before I came on the job. Once I came on the job, we realized that the sign had been approved on paper, but when we started building the signs then there was a question.

Mr. Stenis explained that the site plan that the Board has is one that staff prepared for this variance application. We have a standard note on all our construction plans that signs are not approved with the construction plan; they require a separate sign permit.

Mr. Bollinger added that the signs weren't designed when the plans were submitted. We just knew there would be a sign there.

Mr. Nealis indicated they are moving the pole as far back in the island as possible. Mr. Bollinger said they are planning to locate the shared sign in the island across the driving lane.

DISCUSSION AND ACTION BY THE BOARD OF ADJUSTMENT

Hank Ryan moved to approve the Variance of 5'3" to the 25' front setback for placement of a sign. Tom Sherman seconded the motion.
