Lt. Keesee discussed current vacancies and the recruiting process. The new academy started on October 4th with 11 participants. The Police Department is expecting to move into the Smalley Center the first or second week of January. The Committee would like to attend an Open House Tour.

The COP activity for October was 1353.2 hours partnerships, 95.75 hours problem solving and 37.75 hours education for a total of 486.70 hours. This was the second highest monthly total for the year. Several activities accounted for the higher totals – National Night Out, Badges of buses, Citizens Police Academy and Red Ribbon Week.

MPO Thomas Zermeno discussed the TEAM program. The program has been very successful with many of the Norman Public Schools participating. Because of the popularity of the program, Norman Police at this time is unable to add new schools until more officers are trained to participate in the program. The Police Department is looking at ways to get others involved in the program such as retired police officers as well as Cleveland County and OUPD Officers.

Member Wilson mentioned how important it was for a Police Officer to teach the programs because that helped the children see Police Officers in a different light.
