Item 9, being: REVIEW OF CHILDREN'S RIGHTS COORDINATING COMMISSION ORDINANCE

Commissioner Smith reported that she and Ms. Snider had met with the Mayor Rosenthal on February 24, 2015 to discuss the plan and purpose of the Children's Rights Coordinating Commissions. Commissioner Smith presented the Code of Ordinances for the Children's Rights Coordinating Commission identifying Duties and Powers of the Commission (SEE ATTACHED). At the Mayor's request, Ms. Snider was tasked with gathering the original City Ordinance and meeting minutes for the Commission since it was formed in 1983 and provide the Commission with an overview of the findings. Ms. Snider stated that she plans to present the overview at the June 2015 meeting. The Children's Rights Coordinating Commission would then be asked to approve one of three options at the September 2014 meeting: 1) retain the Commission as is with goals/purpose identified which could require funds and time by Commissioners, 2) merge the Commission with the Human Rights Commission a Commission also supported by the City Attorney's Office, or 3) repeal the Commission if determining that since 1983 state agencies are now in place and the Commission is no longer needed.

It was questioned that if the Commission was repealed, how and through what channel of authority would the public report a problem regarding children's rights and whether or not a report line is available.

Item 10, being: PLANNING FOR 2015 CHILDREN'S GARDEN.

Commissioner Ring reported of plans for the upcoming 2015 Children's Garden. The event will be held Sunday, April 12th at Andrews Park from 12 p.m. or 1 p.m. to 5 p.m. Agencies that will be participating in this year's event have been identified and music secured. Commissioners Smith and Ring plan to meet following this meeting to discuss the event. Commissioner Ring has scheduled a planning meeting for Wednesday, March 11th at 4:00 p.m. Commissioners were encouraged to attend the planning meeting and participate in the event. Commissioner Ring requested the following assistance in preparation of this year's event:

- Youth Council be contacted and invited to participate in the event.
- Request an April Proclamation for Child Abuse Awareness Month.
- Post the event on the City of Norman's website.

City staff will provide follow-up to the above requests.

Item 11, being: MISCELLANEOUS DISCUSSION.

Children's Rights Award for Outstanding Service to Children: Ms. Smith reported of the upcoming Annual Service Award. This item will be on the June 2015 Agenda.

Handicap Accessibility in City Parks: In follow-up from the September 2014 meeting with regard to Norman city parks being handicap accessible for children, Ms. Snider reported that Norman city parks have transfer points; however, are not totally handicap accessible for wheelchairs. The Oklahoma City Zoo has a totally handicap accessible playground for children. The City of Norman is in the process of transitioning its parks from mulch to a synthetic turf. The Commission discussed contacting Norman Forward and identifying the need for a totally handicap accessible playground for Norman.
