### MONTHLY UPDATES

#### Finance Report

Monthly Detailed Finance Report was presented by Anthony Francisco. He updated the Committee on revenue and expenditures in the PSST Fund.

#### Fire Department

Chief Fullingim discussed the heavy rainfall we are experiencing in and around Norman. The Department needs motorized watercraft in order to help stranded persons during the flooding. Other cities in the area have boats to use for this purpose. There's a need for 2 crafts, a rubberized boat and an aluminum boat. Member Greenleaf asked if Committee should get involved and make recommendation for purchase of boats. Chief Fullingim said no.

#### Police Report

There were 736 Community Policing hours in April. Bicycle police are used for patrolling these events. 53<sup>rd</sup> Police Academy begins July 13<sup>th</sup>. We would like to have 20 recruits to cover the 14 vacancies and 6 officers for the SRO program. We have 18 candidates to date.

### DISCUSSION REGARDING CONSTRUCTION PROJECT SIGNAGE

Committee discussed street construction in Norman and the lack of signage directing drivers and flagmen to keep traffic moving safely. Shawn O'Leary, Public Works Director talked and answered questions from the Committee. He told the Committee there were several contractors on most street construction, because utilities have to be relocated, easements have to be cleared, etc.

ITEM 4, being:

### RCC CONSULTANTS, INC. (RADIO CONSULTANTS) AND RADIO SYSTEM UPDATE

Chief Humphrey reported that Phase 1 is complete and they are looking at Phase 2. The RCC Consultant believes that the City can stay within their budget for Phase 2. We cannot complete the new radio system until the Emergency Operations Center facility is constructed. Committee asked for a copy of the March report from the RCC Consultant. Chief said they would do that.

Item 5, being:

UPDATE ON MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE CITY OF NORMAN AND NORMAN PUBLIC SCHOOL DISTRICT FOR THE SCHOOL RESOURCES OFFICER PROGRAM

The Memorandum of Understanding is an ongoing process. Offices of City Manager and Superintendent of Schools are the primary negotiators at this time. This will not go into effect until August 2016 with the 6 School Resource Officers.

Item 6, being:

UPDATE ON POLICE DEPARTMENT VIDEO CAMERA SYSTEM AND USE POLICIES

Video camera was demonstrated to the Committee. Police Department is studying other cities' camera use to determine maximum benefits of the body camera system for citizens and police departments. Bill has been introduced in the State Legislature which can delay many cities' usage. For instance, Oklahoma City Police Department has delayed start of camera use until more questions can be addressed and answered. Committee asked about the federal government funding and asked if the City of Norman could receive some of the funding. Chief Humphrey said there was not any funding, it was just something President wanted to do but Congress did not fund the program. In his opinion, if at a later date there is funding, the smaller cities would receive it.

Norman Police Department is getting 40 in-car cameras and 212 body cameras. We have created a new Lieutenant's position for Professional Standards and they will monitor and supervise this program. Discussion is being held as to length of time to keep videos as to whether it should be for 30 days, 60 days, or 90 days. Security of system is very tight but that doesn't mean it will be completely safe from a "hacker".
