## (3) Agenda

A. Potential skills course opportunities: (Tom)

Tom presented draft presentation on Bicycle Skills Course/ Bicycle Park:

- Pump track
- Freeride flow
- Jump, Pump and flow table top, gap

#### Highlights:

- Dedicated parks with purpose built trails for these activities.
- Size: 160+acres for long mountain bike single-track to 3.5 acres for a bike park with jumps, pump track and skills routes. Possible to be done within a ½ acre.
- o Need certain slopes, certain soil types, IMBA will match community matches in some cases.
- Oklahoma Earth Bike Coalition maintain Draper, Bluff Creek trail; relationship with Clear Bay Trail (BLN lead)
- Examples around the country included in the slide presentation materials (I-5 Colonnade Park in Seattle (Evergreen), Pump track in Brooklyn Bike Park, Plainfield, Illinois - CAMBR (estimated size is included in the presentation)

### Site locations options:

1. Ruby Grant Park

South of Franklin – need to coordinate with the plans for the park to see where it could fit.

2. Sutton Park Annex

Not yet programmed, potential for the skills course

Saxon Park

South of Hwy 9, has a cross-country track already in the area

#### <u>Comments & Ideas</u>

- o Smaller, skills hybrid course connected to a cross-country single-track trail (loop) Gary
- Sutton Wilderness rules in charter that exclude "vehicle use of land" and bicycles are vehicles; but the Sutton Park Annex was purchased by the city (not the wilderness site) should not have prohibition of bicycles. Sutton Park Annex is closer and better access to schools Tom; Sunny connection to the Sutton Wilderness allows multi-member family to arrive in the area for multi-purposes to walk, picnic, ball game and then others connect with the skills park at the Annex, etc.
- Saxon more difficult for kids (pre-teen, teen) to access the system and park on their own (without car ride by parents) – Tom, Kim

- 3. Present to Council with Parks Board together
- B. Engagement with Norman Forward Effort: greenways initiative (Tom)

Greenways Plan – proposed greenway between Ruby Grant Park, Sutton Annex, Saxon Park – the crescent around from northwest heading east and south around Norman.; coordination with Norman Forward, potential amendments to the Greenway Plan

We will continue to monitor the efforts.
