STAFF REPORTS/UPDATES

a. 2015 "Big Read" (Winter Reading Program)

A new reading program called Explore Learning Pathways will begin this winter. Outcomes for the patron are more important than the books read. It is hoped that customers will use the information gained from the books to implement an activity or attend a program.

The Winter Reading Program is a pilot program for the Summer Reading Program and will run December 1-February 29. Participants can log into the website and create a profile and yeti avatar for themselves. They will then browse the learning tracts (fitness, technology, DIY and cooking) and decide what and how they would like to learn. They will set some goals for themselves. Then, as they learn, they will earn badges for reading books, attending programs, searching databases and watching movies.

Prizes will be drawn on March 1. Winners do not need to be present to win. Each branch will have prizes for their customers (names will be drawn from those participating at each branch). Each time a person logs into their account they will get another chance in the drawing.

b. Summer Reading Programs and Events

The Summer Reading Program had 3,025 participants and 1,190 finished their goals. Over 8,000 attended the multitude of programs offered over the summer.

c. Fall Reading Programs & Events: Central & West Branches

The Computer Lab will offer a number of STEM classes. In addition to computer classes there will also be a video production class and for teens an electronic music making workshop. Sessions on Robotics will be offered in November. The librarians will also be visiting schools with the STEM program.

Scary Stories around the Campfire will be held October 27.

d. Central and West Branch Updates

A variety of music programs continue to be held at the West Library. The Friends of the Library Book Sale will be October 16-19.

e. Featured upcoming NPL programs and events

The Fall Garden Workshop and Seed Exchange will be held on September 24. The ever popular event, Touch a Truck will be held September 26 at the Cleveland County Fairgrounds. November is National Novel Writing month. Those interested in writing will want to attend the Want to Write a Novel? program which will take place in October, November and December. On October 27 Dr. Tom Boyd will be signing his book.

Teens will be able to participate in an Apple Pie 101 workshop and leave with a pie. On December 11 for Jedi Day there will be a Holly Jolly program with a Star Wars theme. In September librarians will be visiting all first grade classrooms.
