ITEM 5, being:

PRESENTATION OF ACTIVITIES FROM FIREHOUSE ART CENTER

Douglas Shaw Elder, Executive Director of the Firehouse Art Center presented to the board. He thanked the Parks Board and the Parks and Recreation Department for their support. He announced for the 9th year in a row they have stayed in the black. Almost ¼ of their grant funding from the state is gone. They have been putting away money to save for a rainy day and have a substantial amount of money in the bank that can carry them through for several years. There were 1358 participants in classes this year at the Firehouse. They offer three class sessions; spring, winter and fall in addition to a large summer camp program.

The Firehouse Art Center offers teen courses through their College Portfolio Program. In 2015 the graduating seniors received more than \$400,000 in scholarship offers.

The Firehouse Art Center has partnerships to provide public art in the Norman community. Since 2007 they have invested \$150,000 in Art Education. They are now working with students at Lincoln Elementary School.

The Midsummers Nights' Fair has been suspended for this year. After review they found it had lost money every year since he has been director. Sales were down, bringing artists and food vendors in proved difficult. They have focused on piggy backing with other organizations to offer activities at events such as the Outdoor Movie Series, Medieval Fair and Earth Day.

A written report including a financial report was submitted prior to the meeting. The board acknowledged the report.

ITEM 6, being:

PRESENTATION OF PARK BOARD ACTIVITIES

Jud Foster presented a power point giving an overview of the different divisions in the Parks and Recreation department, their roles and responsibilities and funding. The power point also gave insight as to the role of the Board of Park Commissioners. The board's role is to consider parkland dedication ordinance requirements for residentially zoned plats; propose rules and regulations for the maintenance and operation of parks and recreational facilities; consider policy matters relative to the use of those facilities; and to make recommendations to improve the park and recreational facilities. The presentation covered the Park Land Dedication Ordinance and the Park Development Ordinance, explained their differences and how they were administered.
