PRESENTATION FROM COMMUNITY REPRESENTATIVE REGARDING DEBARR AVENUE CONCERNS AND STAFF STATUS UPDATE ON CITY COUNCIL STREET RENAMING POLICY PROCESS

Several citizens addressed the Commissioners who were present about their concerns with the name of DeBarr Avenue and their efforts to get the name changed. Deon Osborne spoke about these concerns on behalf of Norman Citizens for Racial Justice. Councilmember Breea Clark also shared an update on her efforts to change the street name.
