MONTHLY UPDATES

Finance Report

Kim Coffman gave the update. She stated that the City Council accepted the Annual Report for the PSST Committee at the August 27th meeting. Sales tax is slightly below target for the month, and expenditures are below target. This is mostly due to not having many Capital expenditures. The City Council also approved a contract for design of the Parks/Fleet/Transit/Public Safety maintenance facility at the August 27th meeting. It will be on north base and will use \$265,000 of PSST Fire facility funds.

Fire Department

Deputy Chief Wilson gave the update. He stated that the recruit Academy is set to graduate on October 25th with 16 recruits. We have an ISO rep coming in to meet with us to get ready for the upcoming audit in 2021.

Police Report

Captain Hawkins gave the update. The 58th Academy started last month with 11 Officers for the City and 4 for OU. Dispatch is still 6 dispatchers down. COP hours for the month of August were

907, including 278 hours in DDACTS, 179 hours in COP problem solving, and 450 hours in relationships. Some of the events attended were Coffee with a Cop, National Night Out, and Operation Halo on the first day of school.

DISCUSSION REGARDING PHASE III RADIO CONSULTANTS AND RADIO SYSTEM UPDATE

Major Teuscher gave the update. He stated that we have been doing a lot of fine-tuning. The connection to Oklahoma City has gotten most of the bugs worked out and we are hoping to have that up and running soon. All installations are complete with the exception of Parks and Recreation because we don't currently have the radios.

Member Price asked about all of the changes planned to the Municipal Complex. Chief Foster stated that there are conceptual drawings for the plans, but that is currently as far as we have gotten.
