MONTHLY UPDATES

Finance Report

Kim Coffman gave the update. She stated that revenues are about 10% below budget, mainly because we have not received any payments from the Norman Public Schools for the SRO program. Sales and use tax collections are about 5% below target year-to-date through September. Expenditures are about 20% below target because there have not been many Capital Project expenditures. That will changes once we start construction on the EOC building.

Fire Department

Chief King gave the update. He stated that the order for the new pumper tanker has been placed and we expect to receive it around May of next year. We met with the state ISO auditor for a preaudit meeting. This went well and we expect to hold steady with our previous rating. There is a date set for him to return for the audit once we have received the new pumper tanker. The recruit academy is rolling right along and we will graduate the candidates on Oct. 25th.

Police Report

Captain Hawkins gave the update. He stated that we had 6 candidates interview for the Chief of Police position. The decision will be announced sometime around Oct. 18th by the City Manager. The 58th Academy is still going on with 11 Officers for the City and 4 for OU. Dispatch is still 5 dispatchers down. COP hours for the month of September were 901, including 186 hours in DDACTS, 222 hours in COP problem solving, and 493 hours in relationships. Some of the events attended were Coffee with a Cop, Safety School Advisory Committee, etc. We had another meeting with the downtown business association on the updated liquor laws.

DISCUSSION ON COMMUNICATIONS OFFICER SHORTAGE

Carolyn Glover gave the update. She stated that everywhere is having problems hiring dispatchers. We are currently looking into what incentives we can introduce to entice more people to apply and become dispatchers. We are currently entertaining the idea of maybe working 10 hour shifts so we can have 3 days off a week.

The City is looking to do a job audit, and we will look into this specific position as soon as the audit is complete.
