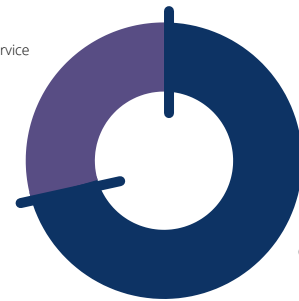

WEEK IN REVIEW

- THE 60TH NORMAN POLICE ACADEMY BEGAN ON FEB. 14 WITH FIVE CADETS.
- NPД RESPONDED TO A SINGLE VEHICLE COLLISION AT 48TH AVE NW AND INDIAN HILLS ROAD AT 2:27 A.M. ON FEB. 14. UPON ARRIVAL, OFFICERS LOCATED A DECEASED INDIVIDUAL WHO HAD BEEN EJECTED FROM THE VEHICLE. A JUVENILE PASSENGER WAS TRANSPORTED TO A LOCAL HOSPITAL FOR MINOR INJURIES. THE COLLISION IS UNDER INVESTIGATION BY THE CIRT TEAM. THIS IS THE SECOND FATAL COLLISION TO OCCUR IN 2022.
- NPД RESPONDED TO A REPORT OF A SHOOTING IN THE 16000 BLOCK OF ROCK CREEK TERRACE ON FEB. 17 AT 11:35 A.M. WHILE THE INCIDENT WAS IN CLEVELAND COUNTY SHERIFF'S OFFICE (CCSO) JURISDICTION, NPД RESPONDED TO PROVIDE MUTUAL AID. UPON ARRIVAL, NPД OFFICERS OBSERVED THE SUSPECT EXITING THE WOOD LINE AND TOOK THE SUSPECT INTO CUSTODY WITHOUT INCIDENT. OFFICER HELD THE SUSPECT UNTIL CCSO ARRIVED ON SCENE. THE VICTIM RECEIVED A GUNSHOT WOUND TO THE CHEST AND WAS TRANSPORTED TO AN AREA HOSPITAL.
- NPД RESPONDED TO A REPORT OF A SUSPICIOUS VEHICLE DRIVING ERRATICALLY AND FOLLOWING AN EMSSTAT AMBULANCE AT APPROXIMATELY 11:21 P.M. FEB. 16. OFFICERS OBSERVED THE VEHICLE FOLLOWING THE AMBULANCE. OFFICERS ATTEMPTED TO INITIATE A TRAFFIC STOP, BUT THE VEHICLE CONTINUED ON MERGING ONTO I-35, DRIVING SOUTHBOUND IN THE NORTHBOUND LANES. OFFICERS SHUT DOWN TRAFFIC ON SOUTHBOUND I- 35 AND UTILIZED A TVI MANEUVER TO STOP THE VEHICLE. UPON CONTACT, THE DRIVER OF THE VEHICLE WAS FOUND HOLDING A LARGE BUTCHER KNIFE WHILE MAKING THREATS TO KILL A FEMALE PASSENGER IN THE VEHICLE. OFFICERS GAVE THE SUSPECT COMMANDS TO DROP THE KNIFE WHICH HE INITIALLY REFUSED. EVENTUALLY, HE PUT DOWN THE KNIFE AND OFFICERS WERE ABLE TO EXTRACT THE SUSPECT FROM THE VEHICLE. HE WAS TAKEN INTO CUSTODY. THE SUSPECT AND PASSENGER WERE TRANSPORTED TO A LOCAL HOSPITAL FOR MINOR INJURIES. TWO OFFICERS WERE ALSO TREATED FOR MINOR INJURIES SUSTAINED DURING THE INCIDENT. THE SUSPECT WAS BOOKED INTO THE DETENTION CENTER ON COMPLAINTS OF DUI-DRUGS, FELONY ELUDING, KIDNAPPING, AND ASSAULT WITH A DEADLY WEAPON. THIS IS THE SECOND INCIDENT INVOLVING A POSSIBLE HOSTAGE IN RECENT WEEKS.
