By signing this agreement, you give up your right and the named minor’s right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of the named minor’s participation in City of Norman Parks & Recreation Department programs, now or any time in the future.**

**Acknowledgment of Risk**

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in **City of Norman Parks & Recreation - Child Care** activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with **City of Norman Parks & Recreation - Child Care** participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with **City of Norman Parks & Recreation - Child Care** participation and that said list in no way limits the operation of this Agreement.

**Norman Parks & Recreation Department** programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of the named minor's participation in **City of Norman Parks & Recreation Department Child Care**, I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's **City of Norman Parks & Recreation Department Child Care** participation.

I hereby certify on behalf of myself and the named minor that I have full knowledge of the nature and extent of the risks inherent in **City of Norman Parks & Recreation Department Child Care** participation and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, the named minor sustains while participating in **City of Norman Parks & Recreation Department Child Care** and that by signing this agreement I, on behalf of myself and the named minor, HEREBY RELEASE Releasees of all liability for such loss, damage, or death. I further certify that the named minor is in good health and has no conditions or impairments which would preclude his/her safe participation in **City of Norman Parks & Recreation Department Child Care**
