Item 1, being:

DISCUSSION REGARDING THE ROOM TAX FUND

Anthony Francisco stated that the discussion today came about due to the recent Council action taken amending the City Code and adding exemptions for Tribal groups to the Room Tax. Part of the amendment to the City Code added language clarifying that the exemption is only for the government and anyone who is doing business on behalf of that entity, not the individual person at all times just because they work for the entity. 50% of Room Tax funds go to convention and visitor attraction, 25% goes to Arts and Humanities, and 25% goes to Park Development capital projects. The pandemic has caused our Room Tax collection to decline heavily through parts of the last two fiscal years, but we are starting to recover.

Dan Schemm talked a little about Visit Norman's mission. He stated they focused on supporting local businesses who were struggling through the pandemic.

Erinn Gavaghan talked about the history between the City of Norman and the Norman Arts Council. She stated that the City of Norman is the only city in Oklahoma that allocates a portion of its Room Tax to the arts. This has allowed the Norman Arts Council to grant out over \$4 million over 40 years. The Public Arts Board was founded as a collaboration between the Norman Arts

Council and the City of Norman and is funded by people making additional donations on their utility bills.

Francisco stated that the City Council has directed about \$100,000 to go to the Norman Arts Council from the American Rescue Plan money.
