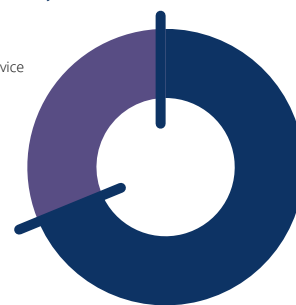

#### WEEK IN REVIEW

- NORMAN ANIMAL WELFARE (NAW) HAD 55 ANIMALS ADOPTED, EIGHT ANIMALS RECLAIMED BY OWNERS, AND TWO ANIMALS TRANSFERRED TO RESCUES THIS WEEK. ADDITIONALLY, NAW TOOK IN 70 ANIMALS TO THE ANIMAL WELFARE CENTER. THERE ARE CURRENTLY 269 ANIMALS IN THEIR CARE WITH 90 OF THOSE ANIMALS PLACED IN FOSTER HOMES.
- COMMUNICATIONS WAS NOTIFIED OF A SUBJECT ATTEMPTING TO GAIN ACCESS INTO VEHICLES AT A LOCAL CAR DEALERSHIP IN THE 800 BLOCK OF INTERSTATE DRIVE ON JUNE 25. PATROL OFFICERS LOCATED A VEHICLE AND A SUBJECT MATCHING THE DESCRIPTION IN A NEARBY HOTEL PARKING LOT. AS THE OFFICER APPROACHED, THE SUBJECT FLED BUT WAS CAUGHT NEARBY AND PLACED IN CUSTODY WITHOUT INCIDENT. THE SUBJECT ADMITTED TO LOOKING FOR AND TAKING ITEMS FROM VEHICLES. HE WAS BOOKED INTO CCDC ON VARIOUS CHARGES RELATING TO THE INCIDENT.
- OFFICERS RESPONDED TO A DISTURBANCE IN THE 1800 BLOCK OF 12TH AVE SE ON JUNE 25. THE SUBJECT WAS ARMED WITH A KNIFE, HAD ASSAULTED ANOTHER PERSON, AND HAD CUT THEIR OWN WRIST. UPON ARRIVAL, OFFICERS ENGAGED THE SUBJECT WHO WAS NOT COOPERATIVE. OFFICERS UTILIZED A TASER TO PLACE THE SUBJECT INTO CUSTODY WITHOUT FURTHER INCIDENT. THE INVESTIGATION INTO THE INCIDENT IS ONGOING.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION AT THE INTERSECTION OF ROCK CREEK RD AND 48TH AVE NE ON JUNE 28. THE INITIAL INVESTIGATION INDICATES THAT A VEHICLE TRAVELING SOUTHBOUND ON 48TH AVE NE DID NOT STOP FOR THE STOP SIGN AT THE INTERSECTION. UPON ENTERING THE INTERSECTION, THE VEHICLE WAS STRUCK BY A PICKUP TRUCK TRAVELING EASTBOUND ON ROCK CREEK RD. THE PICKUP TRUCK DID NOT HAVE A STOP SIGN. A 6-YEAR-OLD FEMALE DIED AS A RESULT OF INJURIES SUSTAINED DURING THE COLLISION. THE COLLISION REMAINS UNDER INVESTIGATION BY THE NPD/OUFD GIRT TEAM.
