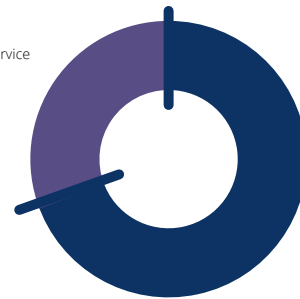

#### WEEK IN REVIEW

- PATROL RESPONDED TO A REPORT OF A FIGHT INVOLVING WEAPONS IN THE 400 BLK OF 12TH AVE SE ON SEPT. 17. OFFICERS LOCATED TWO SUBJECTS FIGHTING IN THE MIDDLE OF A NEARBY STREET. THE INITIAL INVESTIGATION FOUND THE TWO WERE KNOWN ACQUAINTANCES WHO HAD GOTTEN INTO A VERBAL ARGUMENT. DURING THE COURSE OF THE ARGUMENT, ONE INDIVIDUAL PULLED A KNIFE ON THE OTHER. BOTH HAD MINOR INJURIES AS A RESULT OF THE FIGHT BUT DECLINED TO COOPERATE WITH FURTHER INVESTIGATION. ONE INVOLVED SUBJECT WAS ARRESTED FOR VARIOUS WARRANTS AND BOOKED INTO CCDC.
- OFFICERS RESPONDED TO A REQUEST FOR MUTUAL AID REGARDING A RIOT AT AJC ON SEPT. 20 AND ASSISTED WITH RESOLUTION OF THE INCIDENT.
- DET. GLENDA VASSAR WAS AWARDED THE INA MAE "TINY" MILLER AWARD AT THE WOMEN OF LAW ENFORCEMENT CONFERENCE IN TEXAS. THE AWARD RECOGNIZES A LAW ENFORCEMENT OFFICER FOR EXCEPTIONAL ACTS; NOT LIMITED TO ACTS OF BRAVERY OR EXEMPLARY SERVICE TO THEIR DEPARTMENT OR COMMUNITY. THIS AWARD WAS PRESENTED TO DET. VASSAR SPECIFICALLY FOR HER EXCEPTIONAL CAREER AND SERVICE TO SURVIVORS OF CRIME IN THE NORMAN COMMUNITY.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION IN THE PARKING LOT OF A BUSINESS IN THE 1200 BLK INTERSTATE DR. ON SEPT. 22. THE INITIAL INVESTIGATION INDICATES THAT A DRIVER STRUCK A PEDESTRIAN WHILE PULLING OUT FROM A PARKING SPOT. THERE WAS NO INDICATION THAT THE DRIVER WAS DISTRACTED OR DUI. THE PEDESTRIAN WAS TRANSPORTED TO AN AREA HOSPITAL WHERE THEY PASSED AWAY FROM INJURIES SUSTAINED DURING THE COLLISION. THE COLLISION REMAINS UNDER INVESTIGATION BY THE CIRT TEAM.
- PATROL RESPONDED TO A REPORT OF A SHOOTING IN THE 1800 BLK OF SOUTHCREST DR. ON SEPT. 23. ONCE ON SCENE, OFFICERS LOCATED A JUVENILE VICTIM WHO WAS SHOT IN THE LEG. THE INITIAL INVESTIGATION INDICATES THAT A JUVENILE MALE WAS WALKING WITH FRIENDS IN THE AREA WHEN AN UNKNOWN PERSON SHOT THE MALE IN THE LEG. ALL OTHER WITNESSES TO THE INCIDENT WERE UNCOOPERATIVE WITH OFFICERS. THE VICTIM WAS TRANSPORTED TO AN AREA HOSPITAL WITH NON-LIFE-THREATENING INJURIES. THE INCIDENT REMAINS UNDER INVESTIGATION BY THE CRIMINAL INVESTIGATIONS DIVISION.
