WEEK IN REVIEW

- OFFICERS RESPONDED TO A REPORT OF A SUSPICIOUS VEHICLE IN THE 400 BLOCK OF E. DUFFY ST. ON 1/23. UPON ARRIVAL, OFFICERS LOCATED A TRAILER AND VEHICLE RECENTLY STOLEN FROM THE 3200 BLOCK OF BART CONNER DR. OFFICERS WERE ABLE TO RECOVER THE VEHICLE AND TRAILER -- AND IDENTIFY TWO SUSPECTS INVOLVED IN THE INITIAL INCIDENT. THE CASE REMAINS UNDER INVESTIGATION.
- NORMAN ANIMAL WELFARE DISCOVERED A LARGE-SCALE ROOSTER FIGHTING OPERATION DURING MUTUAL AID RESPONSE TO A FIRE INCIDENT IN THE 12200 BLOCK OF E CEDAR LANE RD. ON 1/23. THE JOINT OPERATION LED TO THE SEIZURE OF 77 ROOSTERS AND THE SHUTDOWN OF THE ILLEGAL AND INHUMANE ACTIVITY OCCURRING ON THIS PROPERTY. THE SEIZED ROOSTERS WERE FOUND IN DEPLORABLE CONDITIONS ALONGSIDE EVIDENCE OF BRUTAL TRAINING AND EXPLOITATION OF THE ANIMALS FOR FIGHTING PURPOSES. THE SEIZED ANIMALS WERE TRANSPORTED TO AN OUT-OF-STATE ROOSTER SANCTUARY WHERE THEY WILL RECEIVE PROPER CARE, EVALUATION, REHABILITATION, AND NECESSARY MEDICAL TREATMENT. THIS CASE REMAINS AN ACTIVE INVESTIGATION WITH CRIMINAL CHARGES PENDING.
- NPD PARTNERED WITH CLEVELAND COUNTY SHERIFF'S OFFICE, NORMAN FIRE DEPARTMENT, SODEXO, AND NORMAN PUBLIC SCHOOLS TO HOST THE 48TH ANNUAL CHILI SUPPER BENEFIT DINNER ON 1/25. THE EVENT RAISED OVER \$5,400. ALL PROCEEDS WENT TO THE CHRISTMAS STORE OF CLEVELAND COUNTY, WHICH OFFERS A SHOPPING OPPORTUNITY FOR LOW-INCOME PERSONS WHO WISH TO CREATE A MEANINGFUL CHRISTMAS FOR THEIR FAMILIES.
