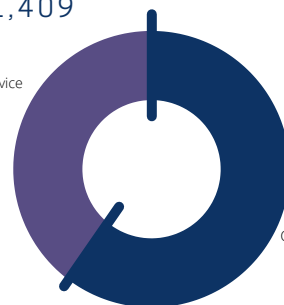

#### WEEK IN REVIEW

- OFFICERS RESPONDED TO A REPORT OF A SHOT HEARD IN THE 400 BLK OF BUCHANAN AVE ON 1/29. ONCE ON SCENE, OFFICERS SEARCHED THE AREA AND WERE UNABLE TO LOCATE ANY EVIDENCE OF A SHOOTING, ANY VICTIMS, OR ANY SUSPECT VEHICLES.
- COMMUNICATIONS RECEIVED SEVERAL REPORTS OF SHOTS FIRED IN THE 300 BLK OF SUMMIT CREST LN ON 1/31. THE INCIDENT INVOLVED TWO VEHICLES THAT HAD SINCE LEFT THE AREA. OFFICERS LATER LOCATED ONE OF THE VEHICLES AND ATTEMPTED A TRAFFIC STOP. THE SUBJECTS REFUSED TO STOP EVENTUALLY CRASHING INTO A PARKED TRAIN IN THE AREA OF 89TH STREET IN MOORE. THE OCCUPANTS THEN FLED ON FOOT. TWO SUBJECTS WERE QUICKLY PLACED INTO CUSTODY. PRELIMINARY INFORMATION INDICATES THAT THE INCIDENT MAY BE TIED TO A SERIES OF STOLEN VEHICLES IN OUR AREA. THE CASE REMAINS UNDER INVESTIGATION.
- NORMAN POLICE LOCATED THE SUBJECT OF A RECENT MISSING PERSON CASE AND HIS VEHICLE IN LAKE THUNDERBIRD WITH THE ASSISTANCE OF OHP. THE INITIAL INVESTIGATION INDICATES HE DIED AS A RESULT OF A VEHICLE COLLISION INTO THE LAKE. THE COLLISION REMAINS UNDER INVESTIGATION BY THE OKLAHOMA STATE PARK RANGERS AS IT OCCURRED IN THEIR JURISDICTION.
- OFFICERS RESPONDED TO A REPORT OF AN ATTEMPTED CAR JACKING IN THE 400 BLK OF 12TH AVE SE ON 2/3. THE VICTIM STATED THAT AN UNKNOWN SUBJECT RAN UP TO THEIR VEHICLE AND POINTED A BLACK FIREARM AT THEM. THE VICTIM WAS ABLE TO DRIVE AWAY DESPITE THE ARMED INDIVIDUAL CHASING AFTER THEM. OFFICERS LOCATED THE SUBJECT NEARBY POINTING WHAT APPEARED TO BE A FIREARM AT THEM. AFTER A BRIEF FOOT PURSUIT, OFFICERS ARRESTED THE SUBJECT WITHOUT FURTHER INCIDENT.
- RECORDS CLERK SUSAN MCLEES, POLICE EMPLOYMENT TECHNICIAN SARA DOHERTY, AND EXECUTIVE ASSISTANT TO THE CHIEF DARCI POE RECEIVED COMMENDATION AWARDS FOR THEIR ASSISTANCE WITH THE DEPARTMENT'S CHRISTMAS COMMITTEE.
- ANIMAL WELFARE HAD 36 ANIMALS ADOPTED, 8 ANIMALS RECLAIMED BY THEIR OWNERS, AND 1 ANIMAL TRANSFERRED TO A RESCUE THIS WEEK. ADDITIONALLY, 50 ANIMALS WERE TAKEN INTO THE ANIMAL WELFARE CENTER. CURRENTLY THERE ARE 124 ANIMALS IN THE CENTER WITH 27 OF THOSE ANIMALS IN PLACEMENT WITH FOSTERS.
